



Dear Ms. Flack,

Following my telephone conversation with Ms. Polly Grow, as well as voice message left for Mr. Wayne Barnett, I now follow Mr. Grow's advice to communicate my ethics/elections complaint directly to you.

Thank you for registering this email as my formal complaint and request for investigation.

As a Seattle resident/voter I now hereby file complaint with the SEEC to examine a unlawful ceding of authority by City Librarian Mr. Marcellus Turner to a private entity to dictate and limit candidate participation in a candidate forum scheduled to take place inside a public building and with consumption of public resources. The said forum is scheduled for the Seattle Downtown Public Library on Thursday, July 14, 6-7 PM.

I and four fellow candidates have called on City Librarian Marcellus Turner to simply invitate every filed 7th CD candidate to tomorrow's forum as a way to avoid the present violation of law. Simple! Our press release is attached. He has so far refused, so I now lodge my official complaint and request that the SEEC investigate and take action. Hopefully SEEC's guidance to City Librarian Turner will prompt his reformation to issue invitations to all candidates prior to the commencement of Thursday's debate. I respectfully request SEEC's rapid evaluation and action. Time is of the essence if abuse of public assets for private and political campaign benefit is to be averted by the City Librarian.

The Librarian's present abdication of managerial control over this SPL event is in violation of the Washington State Constitution Chapter VIII Sec. 7 and SMC 2.04.300.

Seattle Municipal Code 2.04.300 - Prohibition against use of public office facilities in campaigns.

"No elected official nor any employee of his or her office nor any person appointed to or employed by any public office or agency may use or authorize the use of any of the facilities of a public office or agency, directly or indirectly, for the purpose of assisting a campaign for election of any person to any office..."

# Washington State Constitution Article VIII Section 7

"No county, city town or other municipal corportation shall hereafter give any money, or property, or loan its money, or credit to or in aid of any individual, association, company, except for the necessary support if the poor or infirm..."

I will attach what I consider an unacceptable and unrepentant reply from the City Librarian. It is my opinion the no public employee of the Seattle Public Library can violate SMC 2.04.300 via a ceding of authority to a private organization who then does the dirty work of "directly or indirectly... assisting a campaign." Regardless of whatever buffer current and former SPL Librarians have engineered, at the present time Librarian Turner is effectively and exclusively aiding the City Club-invited campaigns of Jayapal, McDermott and Walkinshaw to the exclusion and harm to the campaigns of all other filed candidates for this same office. This violation of law has been committed in collusion with private Seattle City Club, private media interests of KIRO7 and Q13-Fox and perhaps the Downtown Seattle Association (which whom I have not communicated). All private organizations now vested in the present violation of law are, no surprise, intransigent to simply invite all filed candidate so that none will be harmed. I also attach KIRO7's rejection of candidate Arun Jhaveri's request of KIRO to use its influence as a participant to eliminate the present exclusion. Like the City Librarian, and like the Seattle City Club, KIRO punts all to superficial fealty to some opaque and arbitrary participation criteria set by the private Seattle City Club. So far the Seattle City Club has refused to even divulge to me that exact metrics that was used under their generic criteria to restrict their invitation to only three of nine candidates. Seattle City Club is completely opaque and cannot be allowed to persist in leading the Seattle Public Library by the nose regardless of criteria they cook up. Most fundamentally, the brush offs by City Librarian and KIRO7 have no consequence under law.

Conclusion: If the Seattle PUBLIC Library aids one candidate for public office, then its must aid all official candidates equally. Otherwise the public entity abets a gift of private aid and political advantage to some candidate(s) over others via gift of material voter communication advantages.

Remedy requested: All filed 7-CD candidates be invited by the controlling authority of the Seattle Public Library Librarian to the July 14th Forum at the Downtown Library. Further, that forevermore the Seattle Public Library be enjoined from hosting or co-sponsoring any candidate forum to which the SPL has not first invited all filed candidates.

I and my fellow candidates thank you and SEEC for your attention to the urgent matter.
