AGREEMENT TO CONTINUE CASE FOR  
DISMISSAL OR AMENDMENT OF CHARGE(S)

Defendant is charged with the following crime(s), which carry the following maximum and minimum penalties:

- false reporting Maximum Sentence: 90(364) days in jail; \$1000(\$5000) Minimum \_\_\_\_\_
- attempted theft Maximum Sentence: 90(364) days in jail; \$1000(\$5000) Minimum \_\_\_\_\_

The parties jointly move the Court to continue the trial in this case for a period of 24 months from this date. During this period of continuance, defendant agrees to:

- Have no criminal law violations.
- Immediately notify the court of any change of address.
- Not possess or consume alcohol or illegal/non-prescribed drugs.
- Not possess firearms or weapons; forfeit weapons by \_\_\_\_\_.
- Have no contact with \_\_\_\_\_.
- Complete 48 hours of community service by 3-1-20.
- Complete National Traffic Safety Institute Level \_\_\_\_\_ and provide proof of completion by \_\_\_\_\_.
- Obtain anger management evaluation and follow-up treatment as recommended by Probation.
- Defendant shall not refuse a breath or blood test when asked to do so by a law enforcement officer.  Pay \$200 BAC Fee.
- Complete a DUI Victims Impact Panel and provide proof of completion.  Not drive without ignition interlock device for \_\_\_\_\_ year(s).
- Complete Alcohol and Drug Information School (ADIS) and provide proof of completion by \_\_\_\_\_.
- Obtain a \_\_\_\_\_ evaluation from a state certified agency, and complete the recommended treatment by \_\_\_\_\_.
- Other not participate in 2019 voucher program; no non-criminal election code
- SOAP, HIV test, STD Counseling, PPIA \$50, \$1,500, \$2,500 or \$5,000, SIVF \$1,000, counseling fee \$163.50. violations
- pay \$25 community service fee

In addition, as a condition of this agreement with the City, the defendant makes the following acknowledgements, waivers and stipulations:

- Defendant acknowledges that he/she has the following constitutional rights: to a trial by jury, to a speedy trial, to remain silent before and during trial, to refuse to testify against himself/herself, to hear and question the witnesses against him/her, and to testify and have witnesses testify on his/her behalf. Defendant waives all of these rights by entering into this agreement. Nobody has made any threats or promises to get Defendant to enter into this agreement. Defendant agrees that the new commencement date is 3/24/20. Expires 6/24/20.
- Defendant acknowledges that his/her violation or failure to comply with any of the conditions of this agreement will result in the court determining his/her guilt of the charged crime(s) based solely on the police reports and/or other documents/materials attached to or accompanying this agreement. If applicable, Defendant acknowledges that his/her compliance with this agreement will result in the court determining his/her guilt of the reduced crime(s) based solely on the police reports attached to or accompanying this agreement. Defendant waives any defenses to the charged crime(s) or reduced crime(s) and stipulates to the facts in the police reports incident # 17-302133. CONTAINED IN THE COURT FILE.

If defendant complies with the conditions of this agreement, the City agrees to:

- Dismiss the following crime(s) false reporting, attempted theft
- Reduce crime(s) as follows: \_\_\_\_\_
