This letter serves as a formal modification request for the Personal Financial Affairs Statement (F-1) of Seattle City Council Candidate Maritza Rivera ("Mrs. Rivera"). Mrs. Rivera is married to Daniel Kully ("Mr. Kully"), who has ownership interests in three entities 1 and serves in an organizational role in three non-profit organizations. Mrs. Rivera does not have any involvement in the day-to-day operations of these entities nor any relationship to these entities. She does not have any position or play any roles in these entities. Furthermore, Mrs. Rivera's marriage to Mr. Kully by no means makes her knowledgeable about the activities or intricacies of these organizations. Despite this, absent modification of the otherwise-applicable disclosure rules, Mrs. Rivera would be required to report the government agencies and business customers of these entities who provided more than \$12,000 in compensation in the last year. Such a requirement would be "a manifestly unreasonable hardship."

An applicant may request a modification when he or she is "required to report the activities of an entity solely because the applicant's spouse. . .held an office, directorship, general partnership or ownership interest in the entity and the applicant does not have direct knowledge of the information that must be reported[.]" In such a case, the applicant may be permitted to only disclosure:

(1) All payments made by the agency or jurisdiction in which the applicant seeks office,

- (2) The business or governmental customers or clients of the applicant's spouse who provided more than \$12,000 in compensation of which the applicant is aware, and
- (3) Any other business and governmental customers or clients of the entity whose identities are known to the applicant and whose interests are significantly affected by the agency or jurisdiction in which the applicant seeks office.<sup>5</sup>

Mrs. Rivera seeks relief under such a modification. Specifically, Mrs. Rivera requests this modification for the following entities listed on the F-1, including:

- (1) Sound View Strategies LLC,
- (2) Friends of Waterfront Seattle,
- (3) Transportation Choices Coalition, and
- (4) Rainier Golf and Country Club.

Below is additional information to support this modification request.

Mr. Kully has an ownership interest in the following entities.

1. <u>Sound View Strategies LLC:</u> Mr. Kully has a 25% ownership in this consulting firm. Sound View Strategies LLC works with a variety of clients, some of whom are publicly available on their website. Mr. Kully has had no clients from March 9, 2022, to March 9, 2023, through Sound View Strategies LLC. Additionally, Mr. Kully does not have access to the client accounts at Sound View Strategies and therefore does not know how many business customers paid the entity more than \$12,000 during March 9, 2022, to March 9, 2023. Mr. Kully did not receive compensation from any clients at Sound View Strategies during March 9, 2022, to March 9, 2023, and on-going time period. Mr. Kully is unaware whether Sound View Strategy can sort its customer list. Mr. Kully is not involved in day-to-day operations at Sound View Strategies.

In addition, Mr. Kully has an organizational role in the following entities.

- 1. <u>Friends of Waterfront Seattle:</u> This is a non-profit organization focused on the revitalization of the Seattle waterfront. Mr. Kully serves as a Board Member. Mr. Kully is unaware of the number of the number of employees at this entity nor the number of business customers that have paid this entity more than \$12,000 from March 9, 2022, to March 9, 2023. Mr. Kully serves as a volunteer in his capacity as board member and does not receive compensation for his service.
- 2. Transportation Choices Coalition: This is a non-profit organization advocating for better and more transportation in Washington. Mr. Kully serves as the Board Vice President. Mr. Kully is unaware of the number of the number of employees at this entity nor the number of business customers that have paid this entity more than \$12,000 from March 9, 2022, to March 9, 2023. Mr. Kully serves as a volunteer in his capacity as board member and does not receive compensation for his service.
- 3. Rainier Golf and Country Club: Mr. Kully is President of the Board of Directors at the golf club. Mr. Kully is unaware of the business customers that have paid this entity more than \$12,000 from March 9, 2022, to March 9, 2023. Mr. Kully serves as a volunteer in his capacity as President of the Board of Directors and does not receive compensation for his service.

Permitting Mrs. Rivera to disclose only those business and governmental customers of which she has knowledge does not interfere with the purpose of the personal financial statement. First, Mrs. Rivera does not have any vested interest in any of these entities. She is not an owner, board member, or involved in any other capacity. Second, Mrs. Rivera is unaware of Mr. Kully's specific activities with these organizations beyond the knowledge that Mr. Kully volunteers with these entities.

In compliance with the instructions on the F-1 modification application, Mrs. Rivera has disclosed only those business or governmental customers "that would be reportable if the Commission grant[ed] the [requested] modification." In addition, Mrs. Rivera disclosed payments, if any, made by Seattle to the listed entity.
