COLLECTING VOUCHERS

Candidates and Volunteers

- Volunteers collecting any type of democracy voucher must be a named Campaign Representative.
Before a person can collect, the campaign must send the first and last name in an email to our office. See the [2025 Candidate Toolkit](#) and the rule for regulations.
- There is no limit to the number of Campaign Representatives a campaign may have.
- Campaign Representatives are subject to [Rule 16.J](#).
- Candidates do not have to register as a Campaign Representative.

Paid Collectors

- Paid Collectors, defined in [Rule 16.J](#), are required to attend a training and have submitted an attestation prior to collecting.
- Campaigns are strictly limited to a number of Paid Collectors who are paid by the campaign directly or indirectly at any time.
- Candidates do not have to register as a Paid Collector.

All Collectors

- The person collecting a Campaign Replacement Form from a resident must complete the collector portion of the form, located in the bottom right section.
- Try not to let vouchers get wet and please do not fold campaign forms if you are sending paper copies to us.

REPORTING VOUCHER PROCEEDS TO THE PDC

The SEEC is requesting filers do not itemize contributions of \$100 or less when filing reports with the PDC. Voucher users have raised concerns with us about their names and addresses being published on the PDC's website.

The PDC's policy is to publish all itemized contributor information it receives and make it searchable using Google and other standard search engines. We are asking you to not itemize voucher proceeds unless otherwise required to.

When we send you an email notification that your voucher data is ready for download, we will include instructions for ORCA users on how to file the non-itemized C3 with the PDC, and the itemized C3 with the SEEC.

IMPORTANT DATES

- **May 5 - 9, 2025** - Filing week at King County Elections.
- **May 23, 2025** - Last chance for candidates to enter the Democracy Voucher Program by signing the Pledge.
- **May 26, 2025** - Memorial Day. SEEC office is closed.
- **June 19, 2025** - Juneteenth Day. SEEC office is closed.
- **July 4, 2025** - Independence Day. SEEC office is closed.
- **August 5, 2025** - Primary Election Day.
- **November 4, 2025** - General Election Day.

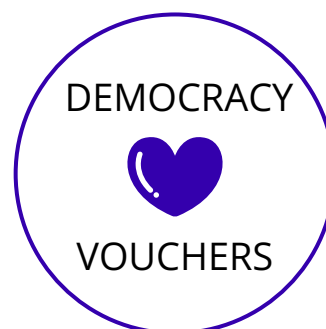


Image of DVP Sticker
