COLLECTING CAMPAIGN REPLACEMENT FORMS

We have been asked to provide clarity on using mobile devices to collect Campaign Replacement Forms (CRF) in the field. Whether collecting CRFs using paper or a mobile device, all existing regulations for in-person CRF collection and documentation apply. An electronic version of the CRF is only allowed to be hosted on the official campaign website, so your mobile device needs to point to the campaign website's CRF. Here is an example of complete collector documentation for in-person CRFs whether collected on paper or a mobile device:

Reminder: If you are processing CRFs that have been passively collected (not collected in person) from the official campaign website, please remind staff to complete the bottom of the form similar to as follows:

REQUESTING RELEASE FROM THE MCV AND/OR THE INDIVIDUAL CONTRIBUTION LIMIT

Under certain circumstances the law allows candidates to request to be released from the maximum campaign valuation and/or from the contribution limit. See page 20 of the Candidate Toolkit for more information.

Campaigns can submit requests for release by email to the DVP. The request must include details about the opposing campaign's valuation and/or the spending of an independent expenditure committee. The Executive Director will review the request and determine whether or not to release the campaign or present the request to the Seattle Ethics and Elections Commission for their determination.
