## 120524.2 APPLICATIONS FOR CERTIFICATE OF APPROVAL

## 120524.21 Spoonfull Thai Kitchen and Bar

Rights-of-way adjacent to 5210 Ballard Ave NW – front and back entrances Jason Patpu and Mike Mew, Business Owners

Proposal for two outdoor dining structures and related heaters, lights, and furniture. The business proposes one structure at its front entrance on Ballard Ave NW and one structure at its rear entrance on 20th Ave NW.

Staff provided photos of the existing storefronts, site plans, floor plans, roof plans, elevations, renderings, material information and furniture, heater, planter, and lighting details. Staff cited guidelines: Guidelines/Specific (3) - Scale of Buildings and Structures; Guidelines/Specific (7) – Transparency; Guidelines/Specific (8) - Landscaping; Guidelines/Specific (9) - Vehicular and Pedestrian Access; Guidelines/Specific (15)(j) - New Construction Guidelines, Materials/Textures.

The applicants presented information about siting, materials, construction, and the intent to increase seating capacity.

The property owner was not in attendance.

The board found that the two separate structures were appropriate because the one on 20<sup>th</sup> Ave NW could bring desirable activation with minimal loss of parking. The board found that the proposed structural knee braces and spacing of the railings were impediments to visual transparency. The board also found that the proposed wheel stops were not adequately subdued in appearance.

Action: Philipp Koman made a motion to approve the application under the following conditions: eliminate all structural knee braces unless they are required for structural integrity; eliminate all wheel stops unless they are required by SDOT; if wheel stops are required they must achieve minimal visible impact; increase the spacing between railing balusters to 3 - 3.5 inches. Antyhony Salazar seconded the motion.
