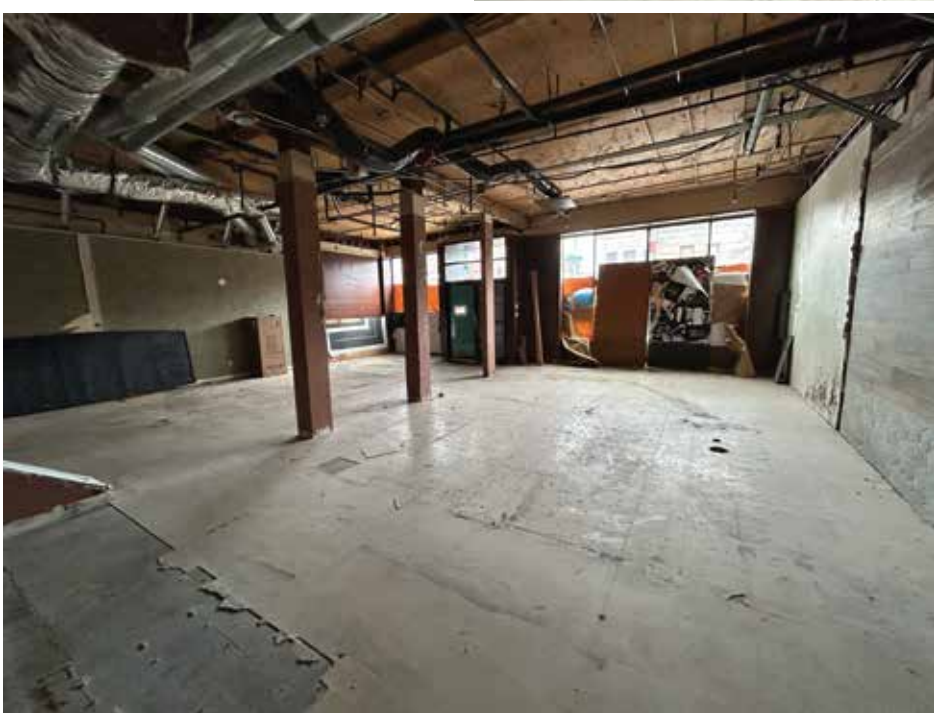

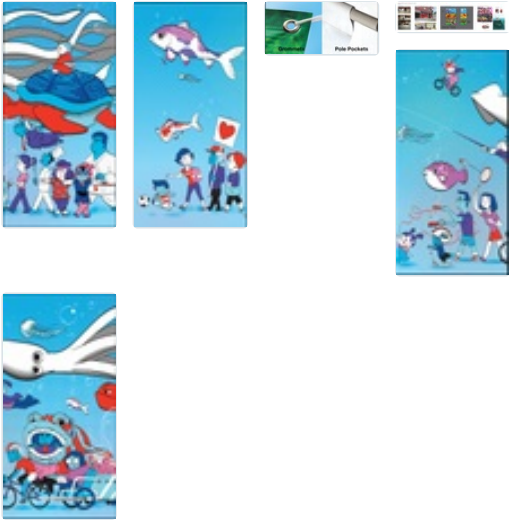

Warranty: McNamara Signs warrants products against defects in materials and workmanship for one (1) year from installation. Excludes temporary signs and lamps. For days 31–365, replacement materials (excluding lamps) will be provided at no cost, but labor will be billed at current hourly rates.
