Briefing on Use and Design proposal for new construction of an 8-story mixed-use building, to include approximately 202 apartments, 66 congregate dwellings, 18 small scale efficiency units, 118 one bedrooms and ground floor retail. No parking is proposed. The lot size is 13,439 sq. ft. The proposal includes demolition of a one-story non-contributing commercial building and related service station island. The focus of this briefing will be on evolution of the proposed massing and building design.
