## 021925.2 PUBLIC COMMENT

Anahi Bendick, Alliance for Pioneer Square, said the revised plan integrated feed back from the last review. #### 021925.5 BRIEFING

#### 021925.51 Prefontaine Fountain Place

3rd Ave

Applicants: Seattle Parks and Recreation, Morteza Berooz and consultant Andy Minton

Briefing on proposed alterations to Prefontaine Fountain (Place) retaining the side panels and altering the remaining site including removing two panels to install stairs and reducing the height of the back of the of the fountain with a profile to match the front of the fountain and altering the bowl or demolishing the bowl and removing the turtles, construction of a new plaza around the fountain.

Morteza Behrooz, Seattle Parks and Recreation and consultant Andy Minton, Berger presented the briefing on the new proposal.

Responding to Board questions, the AP said they could include the turtles or new turtles, if the Board prefers to fill the bowl rather than remove the bowl they can look at fills and the new dome could be tiled or an artist sculpture.

AP said that they reached out to the Committee of 33 and they supported the plans and would like to take the turtles.

Board members asked why not repair the fountain as is. AP said that the deep bowl is a hazard and they are trying to improve CEPTED. Board members had concerns that people would sit on the steps and that no one would use the stairs for mobility anyway. They thought eliminating the steps retained more of the original design intent of the fountain and increased mobility could be achieved a different way.

Board members thought that lowering the fountain retaining the flat profile cap in the back retained more of the original design rather than rounding the back profile to match the front but wanted to see rendering of what it might look like.

The Board would also like to see an option with repairing the fountain as is with the mist water feature rather than standing water.
