Replace Sidewalk

Staff report: The sidewalk is within the Pioneer Square Preservation District, but the building which is being demolished is outside the District boundary so the Board's consideration is just the sidewalk replacement. In 2013, the Board had recommended approval of temporary asphalt sidewalk in this location with the expectation that the new development would be responsible for the permanent sidewalk and lighting complying with the District Standards. Because of the condition of the existing building, demolition and sidewalk replacement is happening now. There is not a proposal to change the existing wood poles at this time.

The existing guidelines provide a formula for concrete including lamp black, however lamp black is no longer used, but a dye color to make the equivalent. My understanding is this rule was made to help new sidewalks better with old sidewalks by greying or darkening the concrete rather than the bright new concrete.

Draft Motion: I move to recommend granting a Certificate of Approval for: Sidewalk replacement as presented.

The Board directs staff to prepare a written recommendation of approval based on considering the application submittal and Board discussion at the *March 1, 2023* public meeting and forward this written recommendation to the Department of Neighborhoods Director.

A. Certificate of approval required. No person shall alter, demolish, construct, reconstruct, restore, remodel, make any visible change to the exterior appearance of any structure, or to the public rights-of-way or other public spaces in a special review district, and no one shall remove or substantially alter any existing sign or erect or place any new sign or change the principal use of any building, or any portion of a building, structure or lot in a special review district, and no permit for such activity shall be issued unless a certificate of approval has been issued by the Department of Neighborhoods Director.

Pioneer Square Preservation District Rules XVII. SIDEWALK TREATMENT

A. Standards

Sidewalk paving and improvements shall be completed with one pound lamp-black per cubic yard of concrete, scored at two-foot intervals. This material shall be used for all projects of 1/4 block or greater size. On small projects, if it is feasible, sidewalk material may be selected as for all projects of 1/4 block or greater size. On small projects, if it is feasible, sidewalk material may be selected to match adjacent sidewalks in color, pattern and texture.

On November 20, 2013, the Pioneer Square Preservation Board recommended approval of the application for:

Construct Railroad Way Plaza along Railroad Way S between Occidental Ave S and S King Street, Reconstruct First Ave including roadway, sidewalks and planted median, Reconstruct S Charles St including the roadway and sidewalk,

Reconstruct a portion of S King Street roadway and sidewalk

The concrete paving stones and metal for the Railroad Way pedestrian path, Columnar Red Maples (Acer rubrum) for Railroad Way, aggregate concrete scored with the "waterfront" pattern, custom pedestrian lighting along Railroad Way, custom event lighting for the new Stadium Plaza, metal detectible warning plates at crosswalks, concrete paving on First Ave S and street signal lights on mast arm poles will become the new standard for this area. All future repairs shall be in keeping with this design or a Certificate of Approval application will be submitted. The asphalt sidewalk, wood poles and cobras lighting on the west side of First Ave S are approved as temporary departures from the District Rules with the expectation that the permanent design for the sidewalk and lighting will be consistent with the Pioneer Square Preservation District Rules.

NOTICE TO APPLICANT: Work must occur <u>exactly</u> according to approved plans and specifications. ANY revisions, omissions and/or additions to plans and specifications must be reviewed and approved by the Preservation Board prior to implementation.

APPEAL PROCEDURE: Any interested person may appeal the above decision to the City Hearing Examiner. The appeal and a copy of this decision must be filed with the Hearing Examiner, PO Box 94729, Seattle Municipal Tower, 700 5th Ave., Suite 4000, Seattle, WA, 98124-4729, before 5:00 p.m. on the fourteenth (14th) day following the date of issuance of this certificate, and must be accompanied by a \$85.00 filing fee in the form of a check payable to the City Treasurer. Appeals must be in writing and must clearly state objections to the decision.
