Such analyses shall be nonpartisan, and confidential to the extent allowed by law."

Background (continued)

Revenue sources within OERF's forecasting purview:

- Retail Sales Tax
- Business & Occupations Tax
- Payroll Expense Tax
- Real Estate Excise Tax
- Private Utility Taxes
- Admission Tax
- Business License Tax Certificate Fees
- Assessed Value of real and personal property
- Value of new construction (as input to Property Tax forecast)

Key Components of OERF Work Program

Office Start-up

- Classification and hiring process for new position (target hire data = April/May)
- Establish MOA's with FAS and SDHR for basic support services
- Create a website to create an online presence for OERF, and most immediately to notice meetings of the Forecast Council
- Establish by-laws and address operational logistics of the new Forecast Council, including schedule of 2022 meetings
- Complete data-sharing agreements with the State's Employment Security Department, as well as FAS.

Policy Research

- Assist Council and Mayor in responding to the financial challenges of the 2023 budget, per Council's Statement of Legislative Intent
- The Forecast Office will continue to work with Central Staff and CBO to assess OERF's capacity for policy work in 2022, and the potential topics of interest

OERF's Official Work Products

- 1. Regional Economic Forecasts (pessimistic, baseline, optimistic); produced four times a year. In future years, we would be adding a fourth regional economic forecast in January to provided updated information (e.g. inflation estimates) for initial budget planning and to provide context for a year-end report. We would NOT be developing a fourth revenue estimate at the same time.
- **2. Revenue forecasts**, as adopted by the Forecast Council; *produced and adopted three times a year* April, August and November.
- **3.** Quarterly reports comparing actual revenues received to quarterly forecasts. This report will include all revenue sources within OERF's portfolio, as well as other significant revenue streams for which quarterly information is available. These reports will also include a narrative summary of the most recent regional economic forecasts, and a description/summary of the national economic forecasting trends as well.
- 4. Monthly summaries of retail sales tax distributions from the State of Washington. These will be simultaneously distributed to the Forecast Council, CBO, and Central Staff. These data are made available by the State on a monthly basis (with a ~2-month lag). The data provide perhaps the most current snapshot of local/regional economic activity. Three-month totals for current retail sales activity will also be presented as part of quarterly reports of actuals relative forecasts.
