# Topic

• Pursuing Alternative Transportation<sup>1</sup>

# **Summary**

A complainant alleged that a named employee used unauthorized force by using their patrol vehicle to stop a subject fleeing on a bicycle.

# **Analysis**

- A named employee used their squad car to redirect or slow a fleeing community member, who fell to the ground. OPA found the use of force to be reasonable, necessary, and proportional under the circumstances but noted the policy did not offer guidance for the scenario.
- A draft SPD Policy 13.032 addresses the pursuit of subjects on alternative vehicles separately from motor vehicles but notes no approved pursuit-ending options exist.<sup>2</sup>
  - At the policy meeting on May 20, 2024, representatives from SPD, OPA, OIG, and CPC discussed the lack of pursuit-ending options for bicycles or scooters. SPD requested that OIG research potential solutions.
- The Police Executive Research Forum (PERF) advises departments to clearly define and state what a pursuit consists of, suggesting departments ought to distinguish between vehicle types within their pursuit policies.<sup>3</sup>
  - PERF has not addressed bicycle pursuits but suggested motorcycles should only be pursued when there is "an elevated risk to the community."<sup>4</sup>
- OPA reviewed pursuit policies from comparable cities.

- O Pursuit policies in San Francisco,<sup>5</sup> Portland,<sup>6</sup> and Sacramento<sup>7</sup> explicitly apply only to motorized vehicles and do not address bicycles.
- O Pursuit policies in Los Angeles,<sup>8</sup> Spokane<sup>9</sup> and Bellevue<sup>10</sup> address the dangers of pursuit-ending tactics like PIT maneuvers and stop-sticks. They also emphasize the need to "weigh the potential consequences" of pursuing motorcycles but do not address bicycles.
  - Bellevue's policy requires assessing "the capabilities of both the involved police vehicles and the vehicle being pursued."
- Chicago balances whether "the necessity to immediately apprehend the fleeing suspect outweighs
  the level of inherent danger created by a motor vehicle pursuit."
- o Given the popularity of non-motorized vehicles and their potential to reach high speeds, pursuing non-motorized and motorized vehicles carries similar risks.

### Recommendations

- SPD and its accountability partners should continue researching and developing best practices for police pursuing alternative transportation and appropriate pursuit-ending tactics.
- SPD should continue to lead in this emerging area by incorporating best practices in its policies and training.
