## Commission Business (9:00 – 10:00 am)

The Commissioners received a staff briefing on the Memorial Stadium project. The Commission also adopted minutes dated November 7 and November 21, 2024. The Commission discussed an upcoming roundtable with City staff on light rail. The Commission discussed topics for their February 20, 2025 retreat.

### Memorial Stadium - public realm enhancements (10:00 - 12:30 pm)

#### **Department Comments:**

Erin Doherty (Landmarks Program Coordinator, DON): While acknowledging that concrete relief panels can provide compatibility with the Seattle Center campus, she strongly encouraged the design team to develop a more contemporary design language distinctly different from Paul Thiry's 1962 World's Fair aesthetic, noting that the current approach risks creating confusion between historical eras. Commission Discussion:

**Art Integration & Funding**: The Commission strongly advocated for expanded art opportunities through increased funding, recommending both Seattle Center's full 1% contribution and a potential voluntary 1% from One Roof. They emphasized the importance of involving indigenous artists, including non-federally recognized tribes, and suggested hiring a teaching artist to coordinate student art programs for the interior spaces.

Architecture & Materials: Commissioners focused on the need to refine the precast concrete wall design to be more distinctly contemporary rather than referential to mid-century forms. They praised the addition of the café while suggesting further study of its scalability and emphasized the critical role of integrated lighting in the project's architectural success. Discussion included concerns about entry gateway designs and the technical aspects of precast panel connections.

**Campus Integration**: The Commission commended the project's thorough integration with the Seattle Center campus, particularly praising the landscape design's 360-degree approach and improvements to the Harrison Street corridor. They noted the successful connection to the International Fountain area and the project's overall contribution to campus cohesion.

**Sustainability & Education**: The discussion centered on making sustainable design elements more visible and educational, emphasizing their importance as teaching tools for students. Commissioners encouraged incorporating learning opportunities around systems like stormwater management and other sustainable features that could engage students directly with environmental stewardship.

## The Commission voted 6-0. The Commission adopted the following condition.

The Commission unanimously approved the project with one key condition requiring subcommittee review of the final precast wall design development. Their approval acknowledged the project's strong evolution and success in creating a student-focused facility that enhances the Seattle Center campus while providing valuable community amenities.
