Advisory Board Retreat

Board member: What is the big picture plan/what is the overarching goal/purpose of the retreat

- Bana sent out a doodle poll ~a week ago
 - Once filled out, a draft agenda will be sent (in about a week)
 - Still missing some responses
 - Includes question on what are the priority items for board members
- Board member- draft agenda was discussed in exec committee, there's too much on the agenda.
 - Wants board to look and emphasize what the priorities for agenda items are.
 - Looking at early April.
 - Suggestions/questions from Board member(s):
 - Add column to discuss why/purpose of discussion per agenda item as a way to keep us on track and help decide what to take out of the agenda



- What is the overarching goal for the retreat?
 - Relationship building with MO
 - Clarity board roles, power, structure, mandate, board vs staff roles/relationship
 - Asset/Resource relationship coordinating Connecting with capital subcabinet, design commission, planning commission
 - Work planning for 2023 and 2024 revamping RFP

Budget Letter

- Looking at a \$200 million shortfall this upcoming year. MO expectation is to be budget neutral in 2024.
 - Second year of bi-annual process for budget, first time with this MO
 - Not a budget memo process this year.
- Board member put the overall EDI project ask to maintain the funding level of previous year as opposed to the \$30mil ask.
 - \circ 22.8 million?
- Board member capital and capacity building funding allocation/spread needs to be discussed during retreat
- Board member there is a need to look at other revenue sources from other depts and outside sources
 - Comp plan and Zoning changes opportunities for more engagement and more funding?
 - Look to wealthy in community to get direct donation support. We as EDI can operate as an information center for philanthropic organizations. Need to work on creating a path to pursue this.
- Board member what is the likelihood/capacity to have some of this work supported by other depts/funding?
 - Capital subcabinet may be a path forward, effort is currently put on hold
- Board member important to attach the narrative of the recession that BIPOC communities especially are going through. *Who* are we working for? Understanding the *importance* of the need.
- Board member has there been an experience where EDI secured funds from different departments?
 - Closest we've come is sharing active projects and sharing funds that are already allocated to said projects to make admin easier.
- Staff will edit based on feedback and bring to retreat
- Board member is there something that we can do to help?
 - Feedback that we just collected is good

Executive Committee:

- Small discussion of hiring process EDI Manager
 - Timeline on revised job description
 - Timing of new hiring June/July earliest
- Retreat
 - Defining roles between board and staff
 - Doing work to create context for new board members
 - Honor transitioning away members
 - Dialogue about ordinance, comprehensive discussion on why we're here and the work we're doing
- Budget Letter discussion
 - Providing guidelines and key priorities to draft
- Ordinance discussion
 - Current needs around issues of term limit, clarifying of powers, Conflict of interest, board roles, etc.
 - Staff provided context on how this was done the first time

Policy Committee:

- Not everyone was able to meet last month, agenda is being pushed to this month WA state public benefit policy and EDI implications
 - Keep judicious record of benefits resulting from EDI investments in community
 - Some of that has an impact on evaluation criteria being asked of from grantees
 - Keeping in mind how this intersects with evaluation committee in the future

Storytelling/Data/Evaluation Committee:

- Met a few times
- Discussed a realignment of work product by quarter
 - Have come to agreement on when specific work items will be completed
 - Had more conversations about details of how that process works
- Standardization on how data is being collected
 - Monitoring, expenditure, and project progress being done/used in the same form as the monitoring team when reporting to Director?
- Once information is collected, discussion on how data will be evaluated and made available
- Diana has experience with data evaluation and offered to help

Youth & Community Engagement Committee:

• Met and discussed the ability (or lack thereof) EDI to have a community platform for EDI projects and resources

- There are not currently enough resources and staff to facilitate that
- Discussed more software options to do that
- Development of a questionnaire that could be sent to all of EDI community
 - Ask them to comment on and identify their youth engagement and involvement
- Willard developed an outreach form to help new board members join subcommittees
 - Subcommittee members can come from community and don't have to be EDI board members
