Elise Rasmussen provided staff updates for OSE.

EXECUTIVE COMMITTEE UPDATES & ANNOUNCEMENTS

Debolina Banerjee gave an update on the upcoming elections for Executive Committee members. Debolina's term is coming to a close. Nominations will go out in August. Individuals can self-nominate or nominate others. All 3 positions are open, but only 2 existing members can serve an additional term.

Nina Olivier gave an update on the comment letter submitted on the Seattle Energy Code. Many individuals have been in conversations with the Mayor's office to ensure energy efficiency. The Mayor's office has accepted several recommendations, and an updated energy code will be provided to the public soon; Nina will present this to the Board once it's available.

Nina Olivier gave an update on the Building Emissions Performance Standard (BEPS) which will go into effect soon. A working group is being set up to draft specific rules, guidance, and compliance strategies for building owners to meet the BEPS requirements. Nina has been asked to serve as a member of this working group and she will be reporting back to the GNDOB on the progress of the working group.

GENERAL BOARD BUSINESS

Steve Gelb shared that Emerald Cities Collaborative is working on a weatherization innovation project in Beacon Hill. Their goal is to reach as many households as possible that meet certain requirements. They are working with El Centro de la Raza and others. If anyone is interested in this or can connect Steve to other members in the community to help get the word out about this project can let Steve know.

Debolina Banerjee gave an update on the Payroll Expense Tax and a community event Puget Sound Sage had about the programs the Tax funds. There will be another event coming up to continue showing support for the Payroll Expense Tax.

Matt Remle gave an update on the upcoming Lunch & Learn they are organizing with other partners to discuss global and local actions led by community groups and contracts.
