


# A Definition of Mutual Aid (MA)

Mutual aid initiatives are grassroots movements that organize to share resources, often using nonhierarchical decision-making and peer-to-peer sharing. They recognize that existing systems often fail to support those most in need and in response, provide direct support for both immediate crises and systemic injustices while also building collective power, social cohesion, resilience, and alternative systems of community support and care.



# Learnings from Hurricane Helene





## Mutual Aid Research

- Partnered with UW CIG to deliver a literature review and final report on the relationship between mutual aid and community climate resilience
- Lit review is on MA broadly; focuses on definitions, strengths and challenges, and opportunities for collaboration
- Report compiles findings from interviews and includes recommendations for the City

# Purpose


Co-create a curriculum that provides climate education to communities on:



# Co-Creation Process

1. Literature Review
2. Monthly development meetings
  - Community partners agreed on topics:
    - Extreme heat & wildfire smoke
    - Extreme winter weather
    - Extreme rain & flooding
3. Teaching Pilots to receive broader feedback

- Host *train-the-trainer* workshops for partners to facilitate the curriculum

## GND Oversight Board Functions

- Provides guidance to support the long-term success of the GND
- **Creates climate-related budget recommendations**
- Engages & collaborates with overburdened communities
- Partners with City Departments to support the equitable implementation of the GND



- 2) OSE, in partnership with City departments, shall develop an inclusive engagement strategy for the CAP that includes the voices of communities that disproportionately experience the impacts of climate change and environmental pollution, youth and young people, workers, private sector, colleges and universities, government agencies at varying scales-including Tribal governments, King County, Port of Seattle, State of Washington, and Federal government. The engagement strategy will consist of the following:
- a) An advisory panel, convened by OSE, to provide input and recommendations on strategies for the CAP that incorporate the latest climate science, advance inclusive and just climate mitigation, adaptation, and resilience strategies that incorporate input from diverse constituencies, especially those most overburdened by climate change.
  - i) The panel shall include a selection of experts in wide ranging topics that touch climate and environmental issues from community organizations, local businesses, academic institutions, labor organizations, non-profit organizations, broad-based coalitions, and philanthropic institutions, the Green New Deal Oversight Board and Indigenous Advisory Council.

# 2026 Funded Recommendations

<p><b>Sustain funding for OSE's Building Emissions Navigator Program</b></p>	<p>Prioritize support for building owners that directly serve frontline communities to build on the existing Building Emissions Navigator Program. The grant program provides coaching, project management, and capital support for under-resourced nonprofit and affordable multifamily housing providers that need their buildings to comply with the Building Emissions Performance Standard (BEPS).</p>	
<p><b>Continue to invest in the Municipal Energy Efficiency Program (MEEP)</b></p>	<p>Continue to invest in MEEP to support upgrades of City-owned community-serving buildings, such as libraries and community centers, for clean energy and climate resilience. Ensure these investments are prioritized for facilities in frontline communities.</p>	
<p><b>Continue to fund clean energy apprenticeships that build equitable pathways to climate careers</b></p>	<p>Continue to create climate career pathways for individuals that are underrepresented in the trades connected to clean energy, especially in priority hire zip codes. Focus on supporting youth, people of color, the LGBTQAI+ community, and women. Ensure there are pathways to union jobs and support targeted local hire practices.</p>	
<p><b>Continue to Green our City, while also creating Green Jobs</b></p>	<p>Continue greening strategies while also creating career pathways in urban forestry with equitable hiring pathways using targeted local hire and low barriers to access. Ensure critical urban forestry work is funded if the US Forest Service funds are rescinded and invest in the implementation of strategies from the forthcoming Tree Canopy Equity Plan. Prioritize investments in frontline communities, which include communities at risk of displacement and priority hire zip codes.</p>	
<p><b>Return funding for the Environmental Justice (EJ) Fund back to its 2023-2024 budget</b></p>	<p>The EJ Fund continues to create an <a href="#">enormous impact</a> in advancing public health, safety, and climate resilience for our communities. The growing pool of applications for the EJ Fund has far surpassed available funding as more and more organizations sought funding for their community-led efforts to advance environmental and climate justice. Investments in community solutions to the climate crises are an integral component to ensuring Seattle's residents who have the fewest resources have what they need to adapt to a changing climate.</p>
