Public Comment

Public Comment from Grace Cheong at the Sunrise Project

I am writing to share about Insure Our Future's 2024 Scorecard on Insurance, Climate Change, and the Energy **<u>Transition</u>**. The key insights and findings include:

- •Climate change can account for over one-third of weather-related insured losses this century, totaling \$600 billion
- •The climate-attributed portion is outpacing the growth of insured losses, rising from 31% to 38% over the last decade
- •For more than half of the companies analyzed, climate losses appear to already exceed premiums earned from fossil fuels
- •Generali became the first insurer this year to adopt restrictions across the oil and gas value chain, but overall industry action has stagnated and falls far short as 2024 becomes the first year to exceed the critical threshold of 1.5°C warming with devastating impacts worldwide.
- •The vicious cycle of insurers exacerbating climate risks and withdrawing coverage for climate risks poses risks to affordable insurance coverage and financial stability – requiring decisive policy and regulatory action to turn this to a virtuous cycle (reduce risks and expand affordable coverage). Our recommendations are in the report. •We hope you will review the report's findings and comment on their significance publicly. Please feel free to reach out to discuss these findings.

We envision a multitude of local, community-centered economies, rooted in democracy and collective self-determination, that are sustainable and equitable, and that create shared well-being.


Objective

• To guide city staff, the Green New Deal Oversight Board (GNDOB), and anchor organizations (MLK Labor, ULMS) in using Community Assemblies as a engagement strategy to gather frontline community input for shaping Seattle's climate-focused policies and actions.

Goals

- Train stakeholders to design and facilitate assemblies that center marginalized voices
- Translate outcomes into actionable recommendations for equitable climate and economic justice strategies

What are Community Assemblies?



Assemblies are participatory spaces where participants come together to learn, deliberate, navigate trade-offs, and collectively make decisions or public recommendations to influence the actions of either government or member-based community organizations.

Types of Assemblies:

- Citizen's Assemblies
- Movement Assemblies
- Community Assemblies (hybrid model)

Utility

- Structured deliberation
- Shared power in decision-making processes
- Co-created solutions towards a just and equitable future for all

Topics: Climate & Environmental Justice

Community Climate Resilience

• How do we best support community-scale interventions and provide resources to cope and adapt to climate-related hazards and impacts?

Climate Workforce

- How do we build an equitable clean energy economy, which includes building generational wealth among people who do not currently have ample access to wealth?
- How do we support workers whose work environments, health, and/or incomes are being negatively affected by climate-related hazards?

Where are we now?

Current stage:

- Analysis of assembly outcomes
- Drafting preliminary anchor reports
- Gather feedback from the board

Next steps:

- Prepare final report
- Identify board's role in aligning outcomes with broader GND goals

Board Discussion & Questions

PEL is seeking guidance from the GNDOB regarding these areas:

- 1. Assembly outcomes: should we include **all** recommendations or prioritize actionable ones?
 - Prioritization criteria: alignment with existing city policies/priorities, feasibility given city resources, authority, and timelines, and advancement of GND goals
- 2. Final report: how would the board like to engage in the report drafting process?
 - Options: small group draft reviews (Community Engagement Committee will be involved), input on messaging/tone, intro/concluding statements from the board
- 3. Communications: what support does the board need from PEL in terms of tailored communication materials related to this work?
 - Options: Slide deck presentation on final report, executive summary, tailored messaging for city leadership, including elected officials, and community stakeholders.
