### PUBLIC SAFETY CIVIL SERVICE COMMISSION January 23, 2023, MEETING MINUTES APPROVED: March 23, 2023

## CHAIR (PSCSC 2.04)

- CALL TO ORDER: Commission Chair Stacy Connole called the monthly meeting to order at 10:02 a.m.
- 2. LAND ACKNOWLEDGEMENT: Commission Chair Connole read the land acknowledgement.
- 3. INTRODUCTIONS: Commission Chair Connole introduced the commissioners, staff, and guests.

4. PUBLIC COMMENT: There was no public comment given in person or written.

## **DISCUSSION ITEMS**

5. APPROVAL OF MINUTES

November 7, 2022, Joint Meeting with CSC- The commission reviewed the <u>November 7, 2022</u>, joint meeting with the Civil Service Commission. Commissioner Connole moved to approve the minutes. Commissioner Nark seconded the motion. The motion passed and the minutes were approved by acclamation.

November 16, 2022, Monthly Meeting- The commission reviewed the <u>November 16, 2022</u>, monthly meeting. Commissioner Connole moved to approve the minutes. Commissioner Leggett seconded the motion. The motion passed and the minutes were approved by acclamation.

### 6. FIRE AND POLICE EXAM UNIT

<u>Fire Update</u>- Rachael Schade reported on the Fire Exams update on behalf of Ms. Grace Matsui. Ms. Schade reported on the development of promotional exams for Fireboat Lieutenant and Fireboat Engineer. The Fire Lieutenant written exam will be March 4 and assessments on May 20. The application period occurred the first two weeks in January. There were 82 applicants for Fire Lieutenant. The written exam for Fireboat Engineer will be June 20, and the practical exam will be September 11-15. Commissioner Nark inquired on vacancies in Fire. Sarah Lee, HR Director stated that there were vacancies due to continuing retirements in the Fire department. Ms. Lee stated that Fire was preparing for the start of a recruit class of 52 at the beginning of February. Dori Towler reported that the current vacancy count for Fire is 82. Ms. Lee alerted the commission that she looked forward to discussing the Fireboat Pilot issues that haven't abated and requested the assistance of Executive Director Scheele, who stated that she would be a part of that discussion.

Police Update-Rachael Schade, Police Exams Administrator: Rachael Schade that an entry level police officer test cycle closes on February 8<sup>th</sup> and candidates may test until February 10. There are 164 applicants, a small group. Ms. Schade reported that a virtual lateral oral board will take place on January 28 for one applicant. Ms. Schade reported the current lateral exam cycle will close on February 15, and on February 17 for testing. 3 applicants are scheduled to take the test. Promotional exams are in development for Police Lieutenant and Captain. The application period was the first two weeks in January. Police Lieutenant written is scheduled for March 3<sup>rd</sup> and assessments on April 24-28. Police Captain exam consists of six separate assessment exercises and will take place March 27-April 1. Ms. Schade reported that while in development for the exams they are currently assembling assessors who come from around the Western US. Ms. Schade reported there was approval for a fourth analyst in the Exams Unit. Interviews were conducted last Thursday.

## 7. EXECUTIVE DIRECTOR REPORT

<u>Departmental Work Updates</u>: Police Recruitment: Ms. Scheele reported that she is meeting with the exam unit and multiple stakeholders several times a week to address testing and recruiting.

<u>Budget:</u> The commission reviewed the budget documents. Ms. Scheele reported the adopted budget has not been uploaded, but a snapshot of the December spending was available.

<u>2023 Commission</u>: Ms. Scheele stated she was very grateful to Commissioner Leggett for staying on while awaiting appointment of replacement.

<u>2023 Commission-Commission Vacancy; Meetings:</u> The commission set the meeting schedule for 2023 and scheduled meeting dates for possible exam protest appeals. Chair: The commission agreed to table the discussion on the 2023 chair until the February 27 meeting.

<u>Council Confirmation of Executive Director Scheele:</u> Ms. Scheele will go before the Human Services and Public Safety Committee January 24<sup>th</sup> for confirmation of her position for three more years.

<u>Fire and Police Commendation:</u> Sarah Lee, Fire HR Director and Alyssa Pulliam, SPD HR Deputy Director commended the commissioners for their volunteer service and also to the staff for their assistance.

- 8. CASE STATUS REPORT: The commission reviewed the Case Status Report.
  - *Constantin v.* SPD, PSCSC No. 22-01-003- Case Update: The appellant notified Ms. Scheele that he was currently seeking an attorney. The scheduling of his hearing is postponed until there is notification of representation.
  - Moore v. SPD, PSCSC No. 22-01-004- Case Update: The commission took no action.
- 9. EXECUTIVE SESSION- To discuss Pending, Potential, or Actual Litigation (*May be cancelled if not needed*): The commission did not go into an Executive Session.

- 11. ADJOURN: All other business before the Commission having been considered, Commission Chair Connole adjourned the meeting at 11:05 am.

The purpose of this confidential memo is to provide background information about how the written exam questions were developed, what bibliography information the questions were based on, and the protest process that preceded the scheduled appeal hearing. As the Police Exams Administrator, I am a subject matter expert on the exam development process, and I am authorized to speak in behalf of the development committee.

## **Background on Test Development**

The 2023 Police Lieutenant Exam Development Committee was comprised of an exam consultant from Testing for Public Safety, 5 Lieutenants, and Fire & Police Exam Administrators Rachael Schade and Adelaide Alderks. Over the course of approximately seven months the committee held many meetings to develop, edit, and complete the written exam.

## Source Materials for the Written Exam

All written exam questions were developed to assess each candidate's knowledge to perform the job for which they are seeking promotion. The written exam questions must be directly sourced from the published exam bibliography. The final exam bibliography was published in the SPD Notices on September 9, 2022 (Appendix A). Shortly thereafter, a compilation of exam bibliography materials was posted on the SPD Sharepoint site for the convenience of sergeants who were interested in participating in the exam. The Exam Development Committee approved all materials that were included in the bibliography and reviewed each question considered for inclusion in the written exam. The questions

themselves are developed by a vendor, Testing for Public Safety. This vendor has 25+ years of experience in developing and validating exams for Police and Fire Departments in the U.S. The vendor worked with the remainder of the development committee to appropriately edit questions that were developed from the bibliography materials.

## Protest/Appeal Details

The written exam was administered on March 3, 2023. There were 27 sergeants who participated in the exam. On March 6 – 8, 2023, exam participants were allowed to review the exam booklet along with the exam key, and to file any protests to exam questions. There were 21 protests filed on 18 different questions that were part of the written exam. There was a total of 189 questions on the administered exam.

On Thursday, March 9, 2023, the exam development committee convened for several hours to carefully consider all the protests filed. Three protests were granted, and one question was eliminated from the test. At the conclusion of this meeting, all candidates were sent an e-mail to inform them of the decisions made on protests filed. (See Appendix B: Email to candidates re: protest decisions sent March 9, 2023.)

One appellant filed timely appeals to four (4) decisions on protests. Following are the development committee's recommendations regarding the appeals filed. For each appeal filed, there is a page summarizing the committee's responses. This is followed by copies of the bibliography material from which each question was drawn.







## EXAMINATION ANNOUNCEMENT For POLICE LIEUTENANT

Seattle Municipal Code Chapter 4.08 and Public Safety Civil Service Rules specify that candidates shall be provided with notice of the time and place and general scope of promotional exams not less than 180 days preceding such examination. The written examination for Police Lieutenant will be held on Friday, March 3, 2023, and the assessment center portion of the exam is scheduled to occur during the period of April 24-28, 2023. The on-line application period for the examination will be January 3-17, 2023. Applicants will be notified of the time and place of the exam following the application period. The following represents the criteria for participation in this examination process, along with the FINAL bibliography.

<u>WHO MAY APPLY</u>: This promotional exam is open to City employees who have received and currently hold a regular civil service appointment to a permanent position of Police Sergeant in the Seattle Police Department, and who meet the following minimum qualifications:

**Education**: Graduation from high school or satisfactory completion of the General Educational Development Test.

**Experience**: Three years of supervisory police experience as a Police Sergeant in the Seattle Police Department.

<u>Substitution</u>: A four-year degree may be substituted for one year of the required experience. <u>Delayed Eligibility</u>: Employees with less than three years of experience as a Sergeant may take the exam for later eligibility if they currently hold the rank of Sergeant and will have three years of experience as a Sergeant before the expiration of the new register on August 28, 2025 (two years if using an educational substitution).

<u>Scope</u>: The written and oral examinations will be constructed to assess job-related knowledge, skills and abilities relating to:

- Basic Management Principles (processes, systems and personnel, employment law)
- Police Operations (principles and departmental practices/resources to solve police problems)
- Police Professionalism (impact of social, legal, ethical, and political environment)
- Communication Skills (written, oral, and community interaction)
- Handling Police Command Problems (SPD policy and procedures/tactical planning and response) Leadership Skills (including issues of motivation and discipline)



## 4.08.040 Public Safety Civil Service Commission

A. There is created a Public Safety Civil Service Commission composed of three members. One member shall be appointed by the Mayor, one by the City Council and one elected by and representing employees. The term of each Commissioner shall be three years; provided, that the term of the first Council Commissioner shall be two years and the term of the first Mayor's Commissioner shall be one year. Each term shall commence on January 1st, and appointments to fill vacancies shall be for the unexpired term. Two Commissioners shall constitute a quorum.

Commissioners may receive compensation for their services as may be fixed from time to time by ordinance.

- B. Officers and employees in the Mayor's office, on the City Council staff, and on the Public Safety Civil Service Commission staff, and employees holding exempt positions shall be ineligible for the office of Commissioner.
- C. All regular and probationary employees who are members of this system are eligible to vote for an employee-selected Public Safety Civil Service Commissioner.
- D. Election shall be administered by the City Clerk as determined by City Clerk rule. Election shall be held during the week beginning on the first Monday in November 2020 and every third year thereafter.
- E. Not earlier than the first Monday in October of each year in which a Commissioner will be elected, nor later than the succeeding Friday, any person who is to become a candidate for Commissioner shall file a declaration of candidacy for office with the City Clerk, on a form furnished by the City Clerk.
- F. The candidate receiving the majority of votes cast shall win the election. If no candidate receives a majority of the votes cast, the two candidates receiving the highest and next highest number of votes shall be candidates in a runoff election at a date and time to be determined by the City Clerk. The runoff election be scheduled so that completion of balloting and certification shall occur before 5 P.M. on the last business day of December of the election year. Notice and balloting shall be the same as for a regular Commissioner's election.
- G. Vacancies occurring in the office of the employee's Commissioner shall be filled at a special election to be called for such purpose by resolution of the City Council.
- H. No City employee who is elected to the Public Safety Civil Service Commission shall suffer a monetary loss or other penalty on account of his/her absence from his/her regular position during regular hours while performing the duties of Commissioner.
- I. Pursuant to the City Charter Article XIX, Commissioners may be removed for cause by the City Council following a hearing and the Mayor's appointee may also be removed by the Mayor upon filing a statement of reasons therefor.

PREHEARING CONFERENCE SUMMARY, NOTICE OF HEARING AND SCHEDULING ORDER

On November 28, 2022, the parties appeared remotely via WebEx, before Executive Director Andrea Scheele for a prehearing conference to discuss preliminary matters prior to a formal hearing in the case. Appellant Andrei Constantin appeared on his own behalf, Assistant City Attorney Catherine Seelig represented respondent Seattle Police Department (SPD), and SPD Deputy Human Resources Alyssa Pulliam attended on behalf of SPD.

The appeal in this matter will be conducted in accordance with the <u>PSCSC Rules of Process</u> <u>and Procedure</u>, and the parties are encouraged to refer to them before bringing a question or concern to the Executive Director.

#### 1. Issue on appeal

The parties discussed the issues on appeal, and agreed to the following statement of the issue:

Was the disciplinary decision made in good faith and for cause? If so, was the discipline

appropriate? If not, what is the remedy?

The parties are required to meet and confer in good faith before bringing a motion or objection related to relevancy or access to the attention of the Executive Director. Rule 6.09(c). Discovery may be prohibited or limited where requests are unreasonable or irrelevant.

The parties agreed to exchange documents and respond to discovery requests in a timely manner. The parties were directed to begin the discovery process after the prehearing conference.

#### 6. Prehearing and Post Hearing Briefs

The parties were informed that prehearing and post hearing briefs will be required.

#### 7. Presiding commissioners for appeal:

The panel will consist of a three-member panel of PSCSC commissioners. Currently, the PSCSC is comprised of Commissioner Stacy Connole, Commissioner Dorothy Leggett, and Commissioner Joel Nark. The is a chance that a new commissioner will be appointed to replace Commissioner Leggett prior to the hearing date in this matter.

#### 8. Alternative Dispute Resolution (ADR):

The parties are encouraged to work towards settlement on their own, through use of the City of Seattle's ADR program, and/or the Executive Director would be happy to facilitate a settlement discussion.

2.03 SELECTION OF CHAIR. The Chair shall be elected from among the Commissioners by majority vote for a one- year term.

2.04 DUTIES OF THE CHAIR - The Chair:

A. Shall preside over Commission meetings.

B. Shall rule on matters of parliamentary procedure.

C. Shall act as hiring authority and primary supervisor for the Executive Director.

D. May sign correspondence on behalf of the Commission.

2.05 ACTIONS OF THE CHAIR

The Chair's actions are subject to review and modification by a majority vote of the full Commission.

## 2.06 DELEGATION OF CHAIR'S DUTIES

In the absence of the Chair, the Chair's authority shall be delegated to another member of the Commission.
