

PUBLIC SAFETY CIVIL SERVICE COMMISSION April 20, 2023, MEETING MINUTES APPROVED: June 22, 2023

CHAIR (PSCSC 2.04)

- 1. CALL TO ORDER: Acting Chair Commissioner Joel Nark called the monthly meeting to order at 9:00 a.m.
- 2. LAND ACKNOWLEDGEMENT: Executive Director Andrea Scheele read the land acknowledgement.
- INTRODUCTIONS: Commissioner Nark introduced the commissioners, staff, and guests.
 - <u>PSCSC:</u> Commissioner Joel Nark, Commissioner Richard Greene. <u>Commission Staff and Counsel:</u> Andrea Scheele Executive Director; Teresa Jacobs, Executive Assistant. Commission Counsel: Joe Levan, Assistant City Attorney.
 - <u>Exams Unit:</u> Rachael Schade, Police Exams Analyst, Adelaide Alderks and Amy Jo Chamberlain, Public Safety Exams Analysts, <u>Fire:</u> Sarah Lee, HR Director
- 4. PUBLIC COMMENT: There was no public comment given in person or written.

DISCUSSION ITEMS

- 5. WELCOME COMMISIONER RICHARD GREENE: Commissioner Nark welcomed newly appointed Commissioner Richard Greene.
- APPROVAL OF MINUTES March 23, 2023, Special Meeting- The commission reviewed the <u>March 23, 2023</u>, special meeting. Commissioner Greene moved to approve the minutes. Commissioner Nark seconded the motion. The motion passed and the minutes were approved by acclamation.

7. FIRE AND POLICE EXAM UNIT

Police Update- Rachael Schade, Police Exams Administrator, was present and gave an update on the entry level police officer exam. An entry level exam cycle closed that week, and scores were expected soon. There were 271 applicants. Ms. Schade also gave an update on the lateral exam process, which was close to concluding. 8 applicants tested successfully in the last lateral entry cycle and part two of the exam process for lateral entry was oral board interviews. They would be conducting 7 interviews on Saturday and one applicant had been rescheduled for his oral board. Police Lieutenant oral boards will be conducted on April 24-28. Assessors fly in on Sunday and they have interviews from Tuesday through Thursday of next week, with Monday being reserved as a training day for all assessors. 27 Lieutenant candidates took the written exam, and all passed. One person removed themself, so 26 will participate in interviews next week.

Ms. Schade reported that the Police Captain exam was completed about 3 weeks ago. There were 14 participants, and once the scores are returned she will create the eligibility register for the rank.

<u>Fire Update</u>- Amy Jo Chamberlain, Public Safety Exams Analyst gave an update on behalf of Fire Exams Administrator, Yoshiko Grace Matsui. Ms. Chamberlain stated that two exams were in development: Fire Lieutenant and Fireboat Engineer. The oral boards for Fire Lieutenant would be on May 20th and there are 54 candidates. The written exam for Fireboat Engineer would be on June 20th and there are 4 candidates.

8. DIRECTOR REPORT

Executive Director Andrea Scheele gave an update on department work over the past month. Entry Level Police: Director Scheele reported on a major project related to entry level police officer. There have been improvements on the exams side, as well as to prehire assessments conducted by the Police Department to the entry level application process. The test has not changed. Every agency involved in hiring police officers is tightening up processes and trying new things to attract qualified applicants.

<u>Department Hiring</u>: Director Scheele reported that the department is working towards hiring a new employee but did not have a selection yet. The first interviews were yesterday, and second interviews are next week, Director Scheele hopes to have someone join CIV in May.

<u>Civil Service Commission:</u> Director Scheele reported that the Civil Service Commission has a new appeal under review. Director Scheele is working to finalize potential candidates for the vacant Civil Service commissioner position.

<u>Budget:</u> Director Scheele shared the department budget report which showed monthly PSCSC-June 22, 2023 Monthly Meeting

expenditures and a comparison to 2022 monthly expenditures.

- 9. CASE STATUS REPORT: The commission reviewed the Case Status Report.
 - Constantin v. SPD, PSCSC No. 22-01-003- Case Update: Director Scheele notified the
 commission of a possibility that Commissioner Greene would recuse himself from the
 hearing and have a pro tem commissioner serve in his place.

10. OLD/NEW BUSINESS

- 2023 Chair: Commissioner Nark noted that the commission was four months into 2023 without a chair, due to awaiting the appointment of a new PSCSC commissioner.
 Commissioner Nark moved to nominate current commission chair Stacy Connole as chair to finish off 2023. Commissioner Greene seconded the motion. There was no further discussion and the motion passed.
- Scheduling Commission Meetings to accommodate Exam Protest Appeals (May, June, July, October 2023): Director Scheele suggested that the commission defer this item or schedule over email since Commissioner Connole was not present. Director Scheele said that she would take the first hand in trying to reach out to commissioners.
- 11. EXECUTIVE SESSION- To discuss pending, potential, or actual litigation (May be cancelled if not needed): The Commission went into Executive Session at 9:25 am. The commission came out of Executive Session at 9:38 am to announce that it would go back into Executive Session. The Executive Session began at 9:55 am and ended at 10:10 am.
- 12. ADJOURN: All other business before the Commission having been considered, acting Commission Chair Nark adjourned the meeting at 10:11 am.

CHAIR (PSCSC 2.04)

- 1. CALL TO ORDER: Commission Chair Stacy Connole called the monthly meeting to order at 10:00 a.m.
- 2. LAND ACKNOWLEDGEMENT: Chair Connole read the land acknowledgement.
- INTRODUCTIONS: Chair Connole welcomed those in attendance. Director Scheele introduced the staff and guests.

PSCSC: Commission Chair Stacy Connole, Commissioner Joel Nark, Commissioner Richard Greene. 4. PUBLIC COMMENT: Captain Jeff Guenther addressed the commission and spoke of the character of the three Firefighters before the commission. Captain Guenther implored the commission to reinstate them.

DISCUSSION ITEMS

- REQUESTS FOR REVIEW OR RECONSIDERATION OF DECISIONS OF THE EXECUTIVE DIRECTOR (Pages 1-49)

The parties were present to request reconsideration of the Executive Director's decision to deny their reinstatement request to the fire register after separation from the city for non-compliance with the City's vaccine mandate and the department's inability to find a reasonable accommodation. Lance Fisher was present on behalf of Jeffrey Vale, Andrew Pittman, and Ian Condon spoke on their own behalf and materials submitted by the parties related to this topic were provided in the packet. The Executive Director described the process for reviewing requests under Rule 10.03 of the PSCSC (Public Safety Civil Service Commission) rules. Requests are acknowledged, separation dates and reasons are verified, and then forwarded to the appropriate authority for approval or denial. The three requesters were limited to five minutes to provide comment to the commission. The commission thanked the parties for attending the meeting to state their cases. The commission notified the parties that they would go into a closed session and issue a written decision in a reasonable period of time.

FIRE AND POLICE EXAM UNIT

<u>Police Update-</u> Rachael Schade, Police Exams Administrator, gave an update on the application and current exam cycle. Ms. Schade reported that there were 129 applicants for the current entry level exam cycle. The application process will close next week, and testing will be on the 24th. Lateral entry application closed last Friday, with five applicants. Out of the five applicants, four have completed all elements of the test successfully, while the fifth one has some components remaining. Ms. Schade also reported on the lateral entry oral board session that was conducted on April 22nd, there were seven interviews scheduled. Four candidates were successful, and their names were certified and have been forwarded to the SPD background check. The Captain and Lieutenant exams have been completed, and the registers will be published Friday, June 23 at 5:00 p.m.

SPD Request for Early Publication of Promotional Registers: Police Captain, Police
Lieutenant-Director Scheele reported on SPD's request for early publication of the Police
Captain and Police Lieutenant promotional registers. Director Scheele approved early
publication and thanked SPD for submitting the request early. The register will be published
Friday, June 23 at 5:00 p.m.

Fire Update- Yoshiko Grace Matsui, Fire Exams Administrator gave an update on the application and current exam cycle. Ms. Grace Matsui thanked Amy Jo Chamberlain, Public Safety Exams Analyst for presenting the update at April's meeting in her absence. Ms. Grace Matsui reported that the Fire Lieutenant Oral Boards will be held this Saturday, May 20th with 53 PSCSC-June 22, 2023 Monthly Meeting candidates expected to go through the process. The Fireboat Engineer written exam will be held

on June 20th, there are 4 candidates. Development Committees are currently forming for the Battalion Chief, Fire Captain, and Fireboat Pilot in the Fall.

- 7. EXECUTIVE DIRECTOR REPORT-Executive Director Andrea Scheele gave an update on department work.
 - Introduction Sarah Butler Operations and Policy Analyst: Director Scheele introduced
 Sarah Butler, who has accepted the position of Civil Service Commission's Operations and
 Policy Analyst. Sarah will provide support in operations, budgeting, contract management,
 and outreach. She will also work on developing training materials and improving
 processes. Sarah will also join the public safety exams team to conduct analysis related to
 the exam processes.

<u>Budget:</u> Director Scheele shared the department budget report which showed monthly expenditures and a comparison to 2022 monthly expenditures. Director Scheele reported that the department is preparing to submit the 2024 budget proposal.

<u>Community Service Preference Points Program</u>: Director Scheele reported that a system for implementation of Community Service Preference Points for entry level Police Officer will take effect for the next Police Officer application cycle on June 1st. Director Scheele stated that Adelaide Alderks, Public Safety Exams Analyst who has taken the lead on this project will be present at the commission meeting in June to give highlights of the program.

- 8. CASE STATUS REPORT: The commission reviewed the Case Status Report.
 - Constantin v. SPD, PSCSC No. 22-01-003- Case Update: Director Scheele notified the
 commission that Commissioner Greene will recuse himself from the hearing and that former
 commissioner Judge Terry Carroll has accepted to sit on the panel for the January 26-28
 hearing.

<u>Motion to Appoint Pro Tem Terry Carroll:</u> Commissioner Nark moved to appoint Terry Carroll as a *pro tem* commissioner for the upcoming hearing. Commission Chair Connole seconded the motion. The motion was approved.

9. OLD/NEW BUSINESS

Scheduling Commission Meetings to accommodate Exam Protest Appeals (June, July,
October 2023)-The commission moved the remaining 2023 meetings to the third Thursday
of the month to accommodate review of exam protest appeals. If there is limited or no
actionable business on the agendas, or absent of a quorum, the commission has the
option to cancel the meeting.

- 10. EXECUTIVE SESSION- *To discuss pending, potential, or actual litigation* (May be cancelled if not needed): There was no executive session.
- 11. ADJOURN: All other business before the Commission having been considered, Commission Chair Connole adjourned the meeting at 11:16 am.

2.13 REVIEW AND RECONSIDERATION OF ACTIONS OR DECISIONS OF THE DIRECTOR. a. The Executive Director may review and/or modify any decision made on behalf of the Commission by the Seattle Department of Human Resources Director or their designee. b. The Commission on its own motion may review and/or modify any action or decision of the Executive Director. c. Any person adversely affected by any action or decision of the Executive Director may request the Commission to revise or modify such action or decision. Such request shall be in writing setting forth with reasonable certainty the action objected to, the grounds supporting the request, and the relief sought, and must be made within 10 days from the date of notice of such action unless established otherwise by City Charter or elsewhere in these Rules. The Commission shall thereupon, if in its opinion good cause is shown, conduct a hearing thereon.

10.03 RETURN TO ELIGIBLE REGISTER AFTER SEPARATION DUE TO RESIGNATION, RETIREMENT, OR SEPARATION FOR MEDICAL OR DISABILITY (NOT RETIREMENT): a. A former employee who resigned, retired, or was separated for medical or disability reasons but not granted disability retirement may request return of their name to a supplemental register to be considered with the open graded eligible register for the classification or rank. Such request must be made within one year from date of resignation, retirement, or separation due to disability; provided, the Executive Director may extend the above time limitation for not to exceed an additional four years upon satisfactory showing that such extension would be to the best interests of the City; b. Any request for return to register under this rule must be supported by written recommendation of the former employing department's appointing authority; c. A former employee whose eligibility is reinstated under this rule shall be certified according to civil service rules. However, the name of such an eligible need be considered only by the department which recommends the return of the name to the register, and the person will remain eligible until appointed and/or the register expires. d. The name of a former employee who seeks reinstatement under this rule may not be returned to a promotional register, unless recommended by the head of the former employing department and approved by the Public Safety Civil Service Commission within one year from the date of resignation. e. Except as provided in 10.02 and 10.04 any return to the City service shall be by examination only.

Thank you for emailing again. I was out of the office on April 3, and apologize for missing your email on my return.

The PSCSC is in receipt of your request for your name to be added to the reinstatement list for the rank of Fire Lieutenant at SFD.

As you may know, PSCSC Rule 10 describes the criteria and procedure for requesting to be placed on the reinstatement register.

My office will verify your separation date and type. If are eligible, we will forward your request to Chief Scoggins with a copy of your request to approve or decline adding your name to the reinstatement register.

We will contact you to let you know the status of your request. The process can take time, but if you have not heard back from the PSCSC in three weeks, please contact publicsafety@seattle.gov for a status update.

If you are approved, your name will be placed on the reinstatement register and SFD will conduct its process to determine next steps.



On April 21, 2023, Executive Director Scheele denied your request for your name to be placed on the reinstatement register for the rank of Fire Lieutenant following separation pursuant to Public Safety Civil Service Commission ("PSCSC") Rule of Practice and Procedure 10.03. On that same day, Teresa Jacobs (Executive Assistant for the PSCSC) sent an email to you which included as an attachment the Executive Director's decision denying your request for reinstatement.

On May 3, the PSCSC received your email requesting appeal of the Executive Director's decision. Your request is governed by PSCSC Rule of Practice and Procedure 2.13 - REVIEW AND RECONSIDERATION OF ACTIONS OR DECISIONS OF THE DIRECTOR, subsection c., which states:

Any person adversely affected by any action or decision of the Executive Director may request the Commission to revise or modify such action or decision. Such request shall be in writing setting forth with reasonable certainty the action objected to, the grounds supporting the request, and the relief sought, and must be made within 10 days from the date of notice of such action unless established otherwise by City Charter or elsewhere in these Rules. The Commission shall thereupon, if in its opinion good cause is shown, conduct a hearing thereon. [Underline in original.]

<u>Timeliness Analysis under PSCSC Rule 2.13.c.</u>

Your request for review and reconsideration of the Executive Director's decision was submitted more than ten days after you were provided notice of the denial. Therefore, the request is not timely under PSCSC Rule 2.13.c. and your request is denied.

I requested to be placed on the lieutenant registry on 4/3/23. After 2 weeks I still had not heard back from you so I sent another email on 4/19/23 verifying that you had indeed received my request. I then received your rejection on 4/21.

Given the fact that my first interaction took nearly 3 weeks to receive a response from you it is very reasonable for me to believe that I would have at least that long to appeal your decision. I requested an appeal on 5/3, 12 calendar days after your rejection was sent. That is only 7 business days after... The rule you cited doesn't state whether it is calendar days or business days that are counted. I think it is reasonable to evaluate my appeal based on this fact and the fact that it took you essentially 3 weeks to respond to my initial request for reinstatement.

If you are not willing to grant this request then please advise me on the process for appealing your refusal.
