# PUBLIC SAFETY CIVIL SERVICE COMMISSION June 22, 2023, MEETING MINUTES APPROVED: July 20, 2023

# CHAIR (PSCSC 2.04)

- 1. CALL TO ORDER: Commission Chair Stacy Connole called the monthly meeting to order at 10:00 a.m.
- 2. LAND ACKNOWLEDGEMENT: Commission Chair Connole read the land acknowledgement.
- INTRODUCTIONS: Commission Chair Connole welcomed those in attendance.

<u>PSCSC:</u> Commission Chair Stacy Connole, Commissioner Joel Nark, Commissioner Richard Greene. <u>Commission Staff and Counsel:</u> Andrea Scheele Executive Director; Sarah Butler, Operations and Policy Analyst, Teresa Jacobs, Executive Assistant. <u>Commission Counsel:</u> Joe Levan, Assistant City Attorney.

4. PUBLIC COMMENT: There was no public comment written or in person.

# **DISCUSSION ITEMS**

5. APPROVAL OF MEETING MINUTES-April 20, 2023-Special Meeting & May 17, 2023-Special Meeting: Commissioner Greene moved to approve the <u>April 20, 2023</u>, minutes. Commissioner Nark seconded the motion. The minutes were approved by acclamation. Commission Chair Connole moved to approve the minutes of <u>May 27, 2023</u>, with two minor changes. Commissioner Greene seconded the motion. The minutes were approved, with changes, by acclamation.

REQUESTS FOR REVIEW OR RECONSIDERATION OF DECISIONS OF THE EXECUTIVE DIRECTOR

<u>Brent Mattila PSCSC #23-05-011RFR</u>: The Requestor, a former Firefighter, requested review or reconsideration of the Executive Director's determination that his request to be placed on the eligible register did not meet the criteria of PSCSC Rules 10.03.

Mr. Mattila was not present. Director Scheele recommended the Commission postpone the hearing on this item until the next meeting: 1) to provide Mr. Mattila with the opportunity to be present, and to 2) ensure that the requestor had adequate notice that his request was filed timely.

Commission Chair Connole moved to accept the recommendation. Commissioner Greene seconded the motion. Commissioner Nark voted in favor of the motion. The motion was approved, and the agenda item will be carried over to the July 20, 2023, meeting.

- 7. PRO TEM APPOINTMENT OF DOROTHY LEGGETT, for the limited purpose of hearing and decision in matter of Constantin v. SPD, PSCSC no. 22-01-003: Commissioner Greene moved to appoint Dorothy Leggett for the limited purpose. Commission Chair Connole seconded. The motion passed. Commission Chair Connole thanked Commissioner Leggett for her service to the City of Seattle.
- 8. FIRE LT. ORAL BOARDS EXAM PROTEST APPEALS: There were no exam protests filed during the protest period, and no appeals.

# 9. FIRE AND POLICE EXAM UNIT

<u>Police Exams Update</u>- Rachael Schade, Police Exams Administrator, gave an update on the current entry-police officer exam cycle. Entry-level and lateral entry applications are open. June 26 is the close date for the lateral exam applications. Captain and Lieutenant exam registers were published May 19. The Sergeant exam development committee has begun work on the 2024 Police Sergeant exam. The bibliography will be published on or before September 1.

<u>Fire Update</u>- Ms. Schade provided the Fire update. The Fireboat Engineer written exam was held on June 20. The practical exam will be in early September.

Community Service Preference Points: Adelaide Alderks, Public Safety Exams Analyst did a presentation on development and implementation of the Community Service Preference Points program. PSCSC Rule 9.21 will be effective for the first cycle beginning after June 1, 2023, in July 2023. The rule only applies to Police Officer classifications of entry level and lateral police officer.

Hannah Kosten of the Fire department inquired about the possibility of implementing a similar program for the Fire department. Director Scheele stated there was no plan to implement such a program for SFD but she would engage in conversation if SFD expressed interest.

10. EXECUTIVE DIRECTOR REPORT- Departmental Work and Budget Update: Executive Director Andrea Scheele gave an update on department work.

<u>Constantin Hearing</u>: There will be a two-day hearing on June 27 and 28.

Staff Retreat: Commission staff will have a half-day retreat in July.

<u>Outreach</u>: Staff is working on developing outreach programs for the Public Safety Civil Service Commission and the Civil Service Commission.

<u>Employee Elections</u>: Director Scheele reported on elections for the PSCSC and CSC which will be held in the Fall. Staff will work with the City Clerk's office on outreach to City employees to promote participation in both elections.

Budget: Director Scheele shared the department budget report.

- 11. CASE STATUS REPORT: The commission reviewed the Case Status Report.
  - Constantin v. SPD, PSCSC No. 22-01-003- Case Update: No further updates.
- 12. OLD/NEW BUSINESS: There was no old or new business.

- 14. ADJOURN: All other business before the Commission having been considered, Commission Commission Chair Connole adjourned the meeting at 10:49 am.

**2.13 REVIEW AND RECONSIDERATION OF ACTIONS OR DECISIONS OF THE DIRECTOR.** a. The Executive Director may review and/or modify any decision made on behalf of the Commission by the Seattle Department of Human Resources Director or their designee. b. The Commission on its own motion may review and/or modify any action or decision of the Executive Director. c. Any person adversely affected by any action or decision of the Executive Director may request the Commission to revise or modify such action or decision. Such request shall be in writing setting forth with reasonable certainty the action objected to, the grounds supporting the request, and the relief sought, and must be made within 10 days from the date of notice of such action unless established otherwise by City Charter or elsewhere in these Rules. The Commission shall thereupon, if in its opinion good cause is shown, conduct a hearing thereon.

10.03 RETURN TO ELIGIBLE REGISTER AFTER SEPARATION DUE TO RESIGNATION, RETIREMENT, OR SEPARATION FOR MEDICAL OR DISABILITY (NOT RETIREMENT): a. A former employee who resigned, retired, or was separated for medical or disability reasons but not granted disability retirement may request return of their name to a supplemental register to be considered with the open graded eligible register for the classification or rank. Such request must be made within one year from date of resignation, retirement, or separation due to disability; provided, the Executive Director may extend the above time limitation for not to exceed an additional four years upon satisfactory showing that such extension would be to the best interests of the City; b. Any request for return to register under this rule must be supported by written recommendation of the former employing department's appointing authority; c. A former employee whose eligibility is reinstated under this rule shall be certified according to civil service rules. However, the name of such an eligible need be considered only by the department which recommends the return of the name to the register, and the person will remain eligible until appointed and/or the register expires. d. The name of a former employee who seeks reinstatement under this rule may not be returned to a promotional register, unless recommended by the head of the former employing department and approved by the Public Safety Civil Service Commission within one year from the date of resignation. e. Except as provided in 10.02 and 10.04 any return to the City service shall be by examination only.

Thank you for emailing again. I was out of the office on April 3, and apologize for missing your email on my return.

The PSCSC is in receipt of your request for your name to be added to the reinstatement list for the rank of Fire Lieutenant at SFD.

As you may know, PSCSC Rule 10 describes the criteria and procedure for requesting to be placed on the reinstatement register.

My office will verify your separation date and type. If are eligible, we will forward your request to Chief Scoggins with a copy of your request to approve or decline adding your name to the reinstatement register.

We will contact you to let you know the status of your request. The process can take time, but if you have not heard back from the PSCSC in three weeks, please contact publicsafety@seattle.gov for a status update.

If you are approved, your name will be placed on the reinstatement register and SFD will conduct its process to determine next steps.
