



Clean Cities Initiative (CCI) Weekly Report

March 11, 2021

Reporting Week March 1 through March 7

Week in Review

This week community clean team focused on two large emphasis areas in addition to the various litter and trash pick-up locations citywide. The two emphasis areas included: Ravenna Park and Kinneer Park. 43 additional Clean Cities sites were also completed. The following summary includes Clean Cities work accomplished by Parks/SDOT Clean Cities Crews.

By the Numbers:

- 3177 needles collected
- 5,980 lbs. of debris removed during the jamboree clean at Ravenna Park and Kinneer Park
- 73,200 lbs. trash collected via Community Clean Teams
- 45 blocks of litter pickup
- 4 locations of vegetation management
- 362 tents counted onsite; 1 abandoned tent removed

Clean Cities Emphasis Areas

- Kinnear Park -3/2, CW crew removed overgrown shrubs from stairway entries for CPTED. The laurel hedge entrance to the lookout plaza above the comfort station was hedge trimmed lower 2-3 feet for CPTED. Along the wall the crew removed overgrown vegetation and invasive ivy from around the trunks of trees. A few trees were removed that were leaning towards parked vehicles on the street causing a potential safety hazard. Fencing was erected around an area and turf seeded to re-establish new grass. The pathway and stairway were blown for a clean look. A small grove of trees was mulched.

- Ravenna Park-3/4, crew limbed up trees near the upper main parking lot and cleared overgrown vegetation along NE 55th St. for CPTED. SDOT Team hedged and line trimmed invasive vegetation from the entrance of the park on NE 58th St to the end of NE 58th St. Shrub beds were cleared of invasive vegetation including ivy.
