

Clean Cities Community Clean Teams Weekly Report

August 12, 2021

Reporting Week August 2 through August 8

Week in Review

This week the community clean team focused on two large emphasis areas including Bell St. Park and Colman Park, as well as the various litter and trash pick-up locations citywide. There were 54 additional Clean Cities sites were completed by the Parks Clean Cities Teams and 26 additional sites were completed by SDOT crews. WSDOT is partnering with Community Clean Teams for rock placement *at* Benvenuto. The following summary includes Clean Cities work accomplished by Parks/SDOT Clean Cities and WSDOT crews.

By the Numbers:

- 1,763 needles collected
- 91,365 lbs. trash collected via Community Clean Teams
- 48 blocks of litter pickup by SDOT crews
- 0.1 miles of vegetation management
- 494 tents counted onsite
- 12 signs of graffiti removed





Clean Cities Emphasis Areas


• Bell St. Park: 8/3. The Downtown crew weeded, laid burlap and mulched beds from 5th and to 3rd along Bell St. The sidewalk was pressure washed in the same location on the southside of the street. Planters and trash cans were pressure washed. The Sr. Gardener limbed low hanging branches for better sightlines. The street was cleaned using the Triverus Municipal Cleaning Vehicle (MCV). The packer along with a small crew removed the tree cutting and weeds from the project.



WSDOT/CITY partnership update:

CCT leadership has broken the I-5 corridor into 5 distinct sections for weekly emphasis work. Last week, the area from Denny to Lake View was inspected by City and State operations staff, looking for "quick hits" of trash mitigation and graffiti abatement. City and State operations will work together and independently as needed to quickly address issues along the corridor. On Aug 12, the area between Denny and Madison is targeted for inspection, including adjacent City streets and on/offramps of I-5.
