**Subject:** 2025 Park Hours Changes Proposal

**Action Requested:** The Superintendent seeks a recommendation from the Board of Park and Recreation Commissioners regarding a proposal to change hours for select parks and boat ramps.

**Summary:** This memo outlines proposed changes to operating hours for some of Seattle Parks and Recreation's (SPR) popular parks and boat ramps. These adjusted hours will address both the large number of visitors at these locations and challenges that arise from illegal and nuisance behavior.

**Background:** SMC 3.02 (Administrative Code) establishes rule-making procedures for City agencies including allowances for Emergency Rulemaking (3.02.050) for 60 days or less and notice requirements prior to the adoption, amendment or repeal of any rule.

Summarized in the table below are the municipal code outlining the Superintendent's authority to set park hours and SPR policies that stem from this authority.

**Recommendation:** The staff recommendation outlined in this section includes permanent park hours changes and 270-day pilots. The driving factors for these changes:

- Support and managing the beach fire programs at Alki and Golden Gardens.
- Respond to community concerns about illegal/nuisance activity at popular summer locations.
- Establish seasonal hours for certain boat ramps to help SPR manage late night, noisy activity at these sites that are not necessarily related to boat launch uses.
- Align hours consistently across sites to maximize effective collaboration with Seattle Police, SPR Park Rangers, and security contractors.

*New Permanent Seasonal Recommendation:* Staff recommend reducing park hours for select parks and boat ramps by one-hour to support staff in closing procedures and mitigate misuse and nuisance behaviors that have become more common in recent years during peak season. These seasonal hours would only run from Memorial Day to Labor Day each calendar year. Outside of this timeframe, operating hours will revert to hours listed in the “current hours” column above. Staff believe this recommendation is consistent

<sup>1</sup> An ongoing adjustment to park operating hours from Memorial Day to Labor Day each calendar year; reducing public access by only one hour.

<sup>2</sup> Hamilton Viewpoint and Magnuson Boat Ramp proposed as permanent change given these hours were previously piloted at Hamilton and align with what is currently advertised at the sites and on the SPR web.

with Section 4.7 of the Park Operating Hours Exception Policy allowing for extenuating circumstances.
