

**Q1:** Is there a survey that gives us more accurate as-built topography or are the appendix drawings the best documentation available?

**Answer:** There is no recent survey, so please work with the information we have provided. We will certainly prepare a survey for Part 3 and beyond.

**Q2:** Is there any specific written feedback that you can provide regarding the first stage -- what did the panel like most about the proposal? Which aspects of the proposal need more attention?

**Answer:** Written feedback is not being provided at this stage. Part 2 is your opportunity to revisit all design documents and expand on your vision. I encourage you to read Parts 1 & 2 in conjunction <u>and</u> the Questions/Answers document provided on the project website: <u>Dr. Jose</u> <u>Rizal Park Renovation - Parks | seattle.gov</u>.

**Q3:** Is there a preference for any proposed artwork to honor the Filipino community exclusively or can it more broadly represent the diversity of Beacon Hill?

**Answer:** We seek your vision based on YOUR understanding of the community, supplemented by the information provided to participants up to this point.

**Q4:** While the Phase 1 brief states that the main focus of this project is the upper level of the park, should I still consider maintenance suggestions for the lower portion? (ex. removal of invasive plants)

**Answer:** This scope of improvements is limited to the site boundaries identified in Part 1. There may be work identified in the future for the improvement of the lower tier functions of the site.

**Q5:** Is there a comparable breakdown of costs from a similar renovation that I can reference to get a better understanding of costs for what I am proposing?

**Answer:** The budget will be determined based on the selected proposal; and depending on the need, the implementation may be in multiple phases over multiple years with multiple funding sources.

Q6: Is there a limit of renderings or exhibits that can be submitted?

**Answer:** No. However, your submission email should not exceed 10MB in size.

Q7: What would be acceptable formats?

**Answer:** Electronic submissions in PDF format are preferred. However, it will be up to you to determine best resolution/quality of your digital material for viewing on conventional computer monitors. We continue to accept hard copies per the instructions noted in the Part 2 call.

Q8: Is an accompanying narrative required, and if so, is there a word/page count?

**Answer:** Part 2 will be read in conjunction with your Part 1 submission, therefore no need to repeat. Feel free to add to Part 2 if you find necessary to elaborate on your vision. Otherwise, any notes or callouts on your visual material to assist evaluators with understanding your ideas are encouraged.

Q9: Will there be another shortlist for interviews, or will all Part 2 submissions get an interview.

**Answer:** It will be up to the evaluators to invite for interviews should they find that necessary.
