

## SEATTLE POLICE DEPARTMENT COMMUNITY POLICE ACADEMY APPLICATION

Community participants will become familiar with various facets of the SPD and gain insight into law enforcement's role in the criminal justice system. It's designed to educate the community on the daily work and operations of the Seattle Police Department (SPD), while also giving the Department an opportunity to obtain valuable feedback from the community.

This **6-week-long program** will be both fun, educational, and challenges the myths and images of law enforcement by providing a realistic view of police procedures. The academy curriculum will include field trips and presentations. Instructors are officers and professional civilians from the Department who are experts in their fields. The classroom atmosphere is positive and highly interactive. Students are encouraged to ask questions and discuss topics of interest with instructors.

Applicants must be 18 years old or older, and agree to a background check. Individuals who are active in their communities, involved in Business Improvement Associations, and involved with Community-Based Organizations are encouraged to apply. Space is very limited.

- Complete your application.
- Attach a photocopy of driver's license or State ID Card.
- Signed acknowledgement of the CPA's "Rules of Conduct".
- Signed photo release form.
- Must pass a Seattle Police Department background investigation.

Failure to submit a complete package may result in your application not being considered.
