

Safe Routes

- Completed 1st Ave S Safety Improvements and continued work on projects on Rainier Ave S, Highland Park Way SW at SW Holden St, and 4th Ave S
- Completed projects to make it safer for students to walk, roll, and bike to **15 different schools**
- Repainted **241 crosswalks** and markings for 317 arterial lane-miles
- Installed one new traffic signal at N 130th St and Ashworth Ave N as part of a
 partnership with the Neighborhood Street Fund program, and completed three traffic
 signal spot improvements







Safe Routes

- Continued construction on two Neighborhood Greenways: a connection to Washington Middle School on 21st Ave S, and in Little Brook on 32nd Ave NE
- Completed **2,886 sidewalk repairs** across 288 different blocks
- Installed 82 new curb ramps, including 53 that were customer service requested
- Completed the N 130th St and Ashworth Ave N Safety Enhancements project, located at a busy intersection near Ingraham High School (partnership with program 4; see photo on previous slide)
- Started construction on the Broadway and John Street Signal which aims to address a crash pattern with left turning drivers

Maintenance and Repair

- Continued **paving** on E Madison St as part of Madison RapidRide G Line project (will result in over 11 lane-miles of repaved roads)
- Prepared to **advertise for construction** for paving projects:
 - 11th Ave NE/12th Ave NE
 - 15th Ave NW
 - Denny Way
 - Beacon Ave S
 - 3rd Ave
 - Roosevelt Way
- Completed 41 paving spot improvements, totaling over 5 lane miles
- Made 48 bridge spot repairs
- Advertised for construction of the McGraw St Bridge seismic reinforcement and expect to begin construction in early 2024; reaching final stages of design on several bridge projects



Maintenance and Repair

- Advanced the **draft alternative analysis report** for the Admiral Way Bridge (North & South)
- **Procured a consultant** for the Jackson St (4th-5th) Bridge and the 2nd Ave Extension Bridge Alternatives Analyses
- **Rebuilt two stairways**: the S Norfolk St stairway and the W Lawton St stairway
 - On the W Lawton St stairway, we added a bike runnel so people riding their bike can dismount and roll it up or down the stairway
- **Pruned over 1,100 trees** and removed obstructions for safer travel in the right of way

Congestion Relief

- Completed work on the Route 44 project
- Continued construction on the Madison RapidRide G Line
- Continued design work on several projects
 - Began circulating RapidRide J Line 100% design plans
 - Progressed towards 100% design of Route 40
 - Completed 100% design and advertised for construction on Route 48
- Completed 75 signal diagnostic evaluations and preventative maintenance on 118 signals, and rebuilt the signal at N 80th St and Linden Ave N
- Added just under two miles to our ITS network by installing 9 new CCTV cameras to monitor traffic conditions & respond to incidents
- Completed 21 transit spot improvements, including 14 new bus benches







Congestion Relief

- **Began construction** in late September on near-term improvements as part of the MLK Safety Improvements project, which implements Accessible Mt Baker
- Built over three blocks of new sidewalks and made 10 crossing improvements, including five new marked crosswalks
- Completed four bicycle spot projects: signage and markings on N 36th St and Burke Gilman Trail, bike wayfinding at S Henderson St and Chief Sealth Trail, a bike lane extension on 12th Ave S, and an improvement on 17th Ave E at E Galer and E Aloha St
- Completed a rail crossing delineation project on S Spokane St east of 2nd Ave S and West Marginal Way SW north of Chelan Ave SW



Financial Summary - Q3 2023

- Invested \$26.2M in Q3 and \$73.1M YTD through Q3 of Levy to Move Seattle funds alone
- Second-highest annual total spending through Q3 and with continued high spending over the last 4 years





Reminder: Budget vs. Spend Plan

Spend Plan ≠ Budget

- Budget is the funding available for a program during the year
- Spend Plan is how much of the funding we expect to use throughout the year
- In Capital Improvement Programs (CIP), unspent budget is available the following year—we call this "carryforward," and it is captured in the following year's spend plan

Spend Plan and Levy Delivery Ahead

- 2023 spend plan is the most ambitious to-date during the life of the Levy to Move Seattle; trending towards the highest annual spending of any year
- Spend plan variance is expected, as projects undergo numerous steps from pre-construction through construction. Examples include:
 - East Marginal Way procurement of water main pipe and coordination with other agencies and funding partners in pre-construction phase
 - Acquiring permits for bridge seismic reinforcement projects
 - Delays in material fabrication during construction phase (ex. on SW Roxbury St and N 130th St projects)
- We continue to grow capacity year after year in alignment with spending, and have added more positions in 2024 to support Levy delivery
