### 2024 Seattle Transportation Levy Update

### **Seattle Transportation Levy Update**

- Thank you, Levy Oversight Committee!
- Levy passing with 66% according to King County Elections; ~250,000 votes for levy
- Will provide approximately \$170 million annually over 8 years
- Next Steps:
  - **Now:** SDOT beginning to hire for vacancies; SDOT developing 2025 workplan in alignment with Council Ordinance and levy development
  - November 21: Seattle City Council action on the 2025-26 budget
  - November 26: Election will be officially certified
  - January 1, 2025: Collection of Levy funds begins
  - Early 2025: Council receives 2025 Levy workplan
  - Early 2025: LOC Recruitment

### **Future Levy Oversight Committee**

Ordinance Summary: Oversight Committee to monitor revenues, expenditures, and program and project implementation, and to advise the City Council, the Mayor and SDOT on the spending of Levy Proceeds and the performance of Levy programs consistent with this proposition in order to ensure transparency and accountability to Seattle taxpayers. The Committee will annually review SDOT's program and project priorities, spending, and revised financial plans; and the Committee may audit Levy funded programs. The Committee may make recommendations to the Mayor and City Council regarding the spending of Levy Proceeds.

- SDOT will work with the Council and Mayor's Office to establish the next LOC in early 2025, pending identification and confirmation of members
- Next LOC will have 19 members
  - Changes from current LOC include: 1 young member selected through Get Engaged program; 1
    resident from each Council District; goal to have ~4 members represent priority census tracts under
    the City's Racial and Social Equity Index & ~2 members with auditing experience
- Future LOC allocated \$1M for auditing and professional services support, aligned with LOC recommendation for auditing funds

### **Safe Routes**





Before (left) and after (right) improvements at Winona Ave N and N 76th St.





Before (left) and after (right) a new crossing on 3<sup>rd</sup> Ave NW to help students access Greenwood Elementary.

- ✓ Completed Safety Corridor projects at SW Roxbury St and Olson Pl SW, and at Winona Ave N & N 76th St near Green Lake
- Completed 8 projects to make it safer for students and families to walk, bike, and roll to school
- ✓ Refreshed markings on 560 lanemiles of arterial streets, meeting the annual goal
- ✓ Installed **two new signals** in partnership with the Crossing Improvements program and made **two traffic spot**improvements

### **Safe Routes**







Upgrade to a Neighborhood Greenway in Cedar Park (left) and new 6th Ave NW Neighborhood Greenway (right).

- ✓ Completed Neighborhood Greenways at several locations including near John Muir Elementary and Wing Luke Elementary schools
- ✓ Made 2,448 sidewalk repairs, totaling approximately 14 blocks of sidewalk
- ✓ Built 85 customer-service-requested curb ramps for a total of 111 for the year
- ✓ Completed the Thomas St protected bike lane
- ✓ Began construction on Yesler Way and 3rd Ave Sidewalk Repairs and N 122nd St Walkway Neighborhood Street
   Fund projects

## Spotlight: Bicycle Safety

- Levy goal: 60 miles of Neighborhood
   Greenways and 50 miles of protected bike lanes
- ✓ Total Planned: ~100 miles
  - Completed Neighborhood Greenway mileage: ~37 miles
  - Completed Protected Bike Lane mileage:~31 miles
  - Projects in progress: ~18 miles NGW &
     ~13 miles PBL



### **Maintenance and Repair**

- ✓ Completed over 11 lane-miles of repaving on Madison St as part of the RapidRide G
   Line - Madison St partnership
- ✓ Continued construction on 11th/12th Ave NE paving project
- ✓ Began construction on 15th Ave W/NW & Ballard Bridge Paving & Safety Project
- Completed approximately 2.8 lane miles of paving spot improvements
- ✓ Completed **59 bridge spot repairs** across several bridges including the Ballard, Magnolia, Fremont, and University bridges
- Fliminated the backlog of 810 bridge spot repairs that existed when the levy was passed in 2015

### **Maintenance and Repair**

- ✓ Completed construction on two seismic reinforcements - the NE 45<sup>th</sup> St Pedestrian Bridge and the McGraw St Bridge
- ✓ Published evaluation findings on the 2nd Ave S Extension and S Jackson St Bridge Planning Study
- ✓ Completed repairs on public stairways at Portage Bay Pl and Bonair Dr SW
- ✓ Pruned over **1,000 trees**, removed over 200 obstructions in the right of way to ensure safe travel, and maintained almost 500 areas of landscaping

### **Congestion Relief**

- ✓ Substantially completed the RapidRide G
   Line Madison St and the Route 48
   Transit-Plus Multimodal Corridor projects
- ✓ Awarded the construction contract for the RapidRide J Line project
- ✓ Continued construction on the Route 40 Transit-Plus Multimodal Corridor project
- ✓ Completed 60 signal diagnostic evaluations, and performed preventative maintenance at 230 signals
- ✓ Continued work on Intelligent
  Transportation System improvements on
  East Marginal Way, in Beacon Hill, and
  three intersections on E Roanoke St
- Completed 11 transit spot improvements



### **Congestion Relief**





- ✓ Completed all work on the Martin Luther King, Jr. Way Safety Project to enhance safety and access to transit and local destinations in line with the vision of **Accessible Mt Baker**
- ✓ Completed 10 blocks of new sidewalks across three projects & 15 crossing improvements
- ✓ Began construction on the SPU Broadview Partnership, project (sidewalks along Greenwood Ave N from N 125th St to N 130th St and neighborhood greenway on 1st Ave NW)

## **Congestion Relief**

- ✓ Completed 4 bike spot improvements
- Continued construction on the East Marginal Way project, which included roadway paving south of S Hanford St, installing electrical and signal conduit, completing watermain and hydrant installation, and more
- ✓ Completed a freight spot improvement on East Marginal Way SW between S Front St and S Michigan St

### Reminder: Levy to Move Seattle Oversight & Reporting

### **Levy Oversight Committee (LOC)**

- First met in Spring 2016, the first year of MSL
- Per 2015 Levy Ordinance, the current LOC will conclude at the end of December 2024
- December 3 meeting will be 1 hour wrap-up and 1 hour social

### Levy to Move Seattle Reporting

- Through 2024, SDOT will publish quarterly and annual reports
- In 2025 and in 2026 (or through when most MSL funding is spent), SDOT plans to publish a combined Annual Report and Delivery Plan (i.e. no quarterly reports)





## Summarizes distribution of deliverables by equity priority area


#### Distribution of Deliverables



#### Summary: Deliverable Distribution




### Distribution of Spending
