# Rapid Ride J Line Presentation Darrell Bulmer and Garth Merrill, SDOT

- Q: Will the pedestrian areas adjacent to bike lanes have visual or tactile options for separation?
- A: Intersections will have green crosswalk for bicycles and separated from the white markings meant for pedestrians. Along east lake –bi-directional bike lanes will go behind the stations and separated. Buses will be doing in-lane stops with the traffic. Crossing of bike lanes from the station platform to the sidewalk the bike lanes will be stripped green, raised and marked for pedestrians. Example near Roosevelt. The other area on Fairview near Aloha we are updating the design currently. We have a mixing zone and are working on keeping them

separated.

# **Seattle Transportation Plan Update**

## **Radcliffe Dacanay, SDOT Principal Planner**

- Q: Actions included are high level right now, next phase will it be more specific?
- A: specific to applying actions in certain locations. For example create low traffic streets or expand Stay Healthy Streets where and how to create networks out of existing programs. Make better signage and permanent infrastructure. What kinds of infrastructure would we need to make.
- Q: Replacement of street illustrated?
- A: Compliment, not replace. STP People Spaces and Public Spaces (PSPS) think how we might create people priority streets. How might we expand on few pedestrian only locations and connect to make a network and expand our shared streets. We need to explore how to secure funding to make it happen. Pricing our right of way to regenerate revenue to pay for these ideas.
- Q: Does this translate to project lists every year or broader measurement of success?
- A: We will have broader policies. Certain situations could freight and transit lane share space?
   Managing our expectations to move from A Z and car culture of 15-20 min, our future will be
   different and may not be fast by car with many other options, especially short trips. To be able to
   those, we would have 6-12-20 year project list that would align with the land use growth
   concept
- Q: Once complete will there be other ways of measuring your success?
- A: There will be a monitoring component. High level of VMT traveled and reduction. Encourage
  folks to drive less. Measuring greenhouse gas emissions; miles of implementation of networks
  (ex SHS, bike lanes). Speeds on arterials are exceeding posted speed limits and hope to have
  conversations to manage speed and increase safety; explore different methods of data collection
  and improve our education campaigns.
- Comment: Plug for neighborhood greenway. Queen Anne is working on Pedestrianizing Crockett Street. A goal is to work with the city to make this a process that is replicable in other neighborhoods.
- Response: working with a number of colleagues and Crockett St does come up. No explicit
  program to pedestrianize streets. Current options are use existing School Streets or Stay Healthy
  Streets and turn them up a notch re-prioritize them for people with minimal design options
  and overtime as funding becomes available we can do a real transition of some of these spaces.
