Lynwood Link Connections - Phase 3

- Background
 - Four new stations in 2024, and one in 2026
 - o Project hits 23 routes, 15-all day and 8 peak-only
- Project goals
 - Improve mobility
 - Equitably inform, engage, and empower customers
 - Deliver integrated service with Link
 - o Improve efficiency, effectiveness, and environmental sustainability
- Currently on phase 3
 - Have been incorporating feedback throughout the whole process, addressing priorities
- Proposal highlights
 - Light rail provides north-south service allowing for more east-west bus service to be added
 - Maintain connections to schools and community destinations
 - Shift toward an all-day frequent network that includes more evening and weekend service
- Phase 3 Public Engagement
 - Shared proposal w/ public and stakeholders
 - Public online survey, general public outreach
 - o Engagement lessons learned

- Increasing number of bus stop signs
- Metro homepage banner
- Simplify route sheets
- Shorter surveys

STM Annual Performance Report

- Background
 - STM was approved November 2020 w/ 80% voter approval
 - Levies a 0.15% sales tax from April 2021 to March 2027
 - Raises around \$50M/yr
- Fund use breakdown
 - Metro Transit Service 55%
 - Transportation Access Program 13%
 - Emerging mobility needs 12%
 - Capital Projects & Spot Improvements 18%
- Transit service trends
 - 250k hours of annual transit service hour investments delivered in 2019
 - By 2022 135k STM annual service hour investment; changed due to Vocid-10 and different funding structure
 - Transit ridership in Seattle has followed national trends
 - Slow steady increase from 30-60% of pre-Covid levels
 - Lasting changes in "peakiness" of ridership
- Transit service investments
 - o Equity centered investment priorities
 - o 2022, STM funded 3233 additional weekly bus trips on routes w/in Seattle
 - 2480 on weekdays 496 per day
 - 311 on Saturdays
 - 442 on Sundays
 - 20% of these trips are during AM or PM peak commute periods
 - 80% of trips support off-peak travel
 - Over half of STM funded routes meeting FTN targets and 73% of routes at 95+% of FTN targets
- Transportation Access Program
 - Focuses on removing financial burden from accessing transit for focused populations
 - Programs include
 - Recovery Card Program
 - Orca Opportunity Promise Scholars

- Orca Opportunity Seattle Housing Authority
- Orca Opportunity Youth
 - Wound down as state now sponsors free youth transit.
- Educational and Other Programs
 - Youth Ambassador Program
 - Senior Programming
 - Partnered w/ senior centers throughout cSeattle
 - Uplift Seattle's Equitables Access to Transit (U-SEAT)
 - New partnership to research effect of free transit on employment outcomes
 - Downtown Circulator
 - Partnership w/ local nonprofit and King County Metro
 - Free fixed route, daytime shuttle meant to connect low-income and/or disabled folk to services downtown
- Emerging Needs
 - Up to 9 million dollars may be used annually to support emerging mobility needs related to the pandemic, the closure of the west Seattle bridge, etc.
- Transit Capital Projects
 - Covid recovery bus lane projects
 - Rainier Ave S Bus Lane Project
 - 15th ave W and Elliott Ave W
 - Aurora Ave N
 - Some lack of progress on this one
 - Limited to \$3M spending cap
 - Transit Spot Improvements
 - Delivered w/ STM and Move Seattle Levy funds
 - Positive impact on 15 routes
 - Transit corridor planning and design
 - STM provides funds to initiate new projects and leverage grants for long running multimodal corridor improvements
