Introductions

Seattle Transportation Plan - Overview and timeline:

- 20 year plan/vision for transportation in Seattle and strategies to achieve.
- STP will inform development of a new transportation funding package, align with 2024 comp plan growth strategy
- Co-created with community.
- Currently have separate modal plans that will be incorporated into one transportation plan.
 - Components: pedestrian, bicycle, transit, freight, people street and public spaces, curbside management, emerging and new mobility, vehicular.
 - Content: policy framework, performance measures, priority investment networks, program and project needs, prioritization framework, funding strategy

- Timeline: transmit Mayor's recommended plan to City Council in June/July 2023
 - Continuous community engagement
 - 8 TAB engagements briefings/workshops

Transit-Plus Multimodal Corridor Program

- Focused on making bus trips faster and more reliable
- Madison BRT: concrete paving resumed, no impact to substantial completion. Revenue service date Sept 2024.
- RapidRide J Line (Roosevelt): timeline increased for COVID impact review, new design for U District option, and add'l environmental review. Revenue service in 2026.
- Delridge Way SW RapidRide H Line: substantial completion in Fall 2021. Revenue service shifts to March 2023 to allow KCM to complete construction outside of Delridge portion.
- Route 44 (Market): delays due to concrete strike.
- Route 7 (Rainier): notice to proceed end of May due to concrete strike. Substantial completion in Q3 2022.
- Route 40 (Fremont): NEPA work begun. Outreach begun. Completion in 2024.
- Route 48 (23rd Ave BRT): more narrow scope due to other improvements in the area. Wrapping up complete streets review. Completion in 2023.

Board Business

- WSBLE DEIS letter discussed and adapted.
- Major updates: recruitment new get engaged member. 2021 Move Seattle levy annual report released.
