Introductions

Motion: Art moved to approve the April mtg minutes. Minutes were approved.

Transit Performance Policy

- Transit ridership since 2019 commute peaks have significantly flatten.
- Policy outcomes: priorities and standards for performance; understand needs; project metrics; consistent implementation
- Community input: improve equity in transportation options; transit needs to be an easier choice; roads will feel safer if more ppl take transit
- Maximum to low priority segments. Priority increases with high passenger loads/routes.
- Performance metrics: travel time reference ratio (ratio of travel times by times of day); travel time per mile; headway consistency
- Project evaluation: move beyond comparing time gained for transit vs time delay for drivers tie to SDOT goals and values equity, safety, climate and mode shift
- Policy application: use 2019 data to apply prioritization and performance standards systemwide; ID street segments performing below standard

• Implementation: apply policy to assess performance, implementation guidance around public outreach, incentives and mode shift, project design, and before/after studies and data collection

2020 Seattle Transit Measure Year 1 Annual Report

- STM effective April 2021-March 2027, levying a .15% sales tax
- 72% on KCM service; can spend up to \$3M per year on transit supportive capital projects
- Services adjusted during pandemic to meet revenue changes, including cuts early in the pandemic and with the Northgate Link route restructure
- Transportation Access Program ORCA opportunity providing subsidized ORCA cards and education programming
- Notes for TAB member at council mtg:
 - Investments have been off-peak service investments
 - Strong equity approach to cutting service hours
 - ORCA opportunity and recovery card programs
 - Revisiting spend priorities avoid a pile on to the program while balancing realities on ability to purchase service
