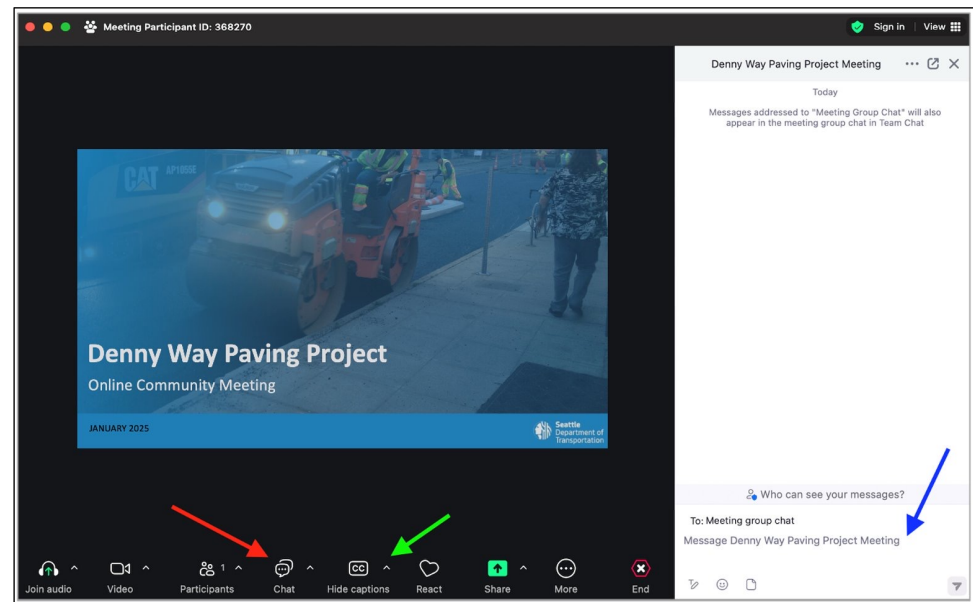


Meeting Format

-3 Concrete Curb Bulbs

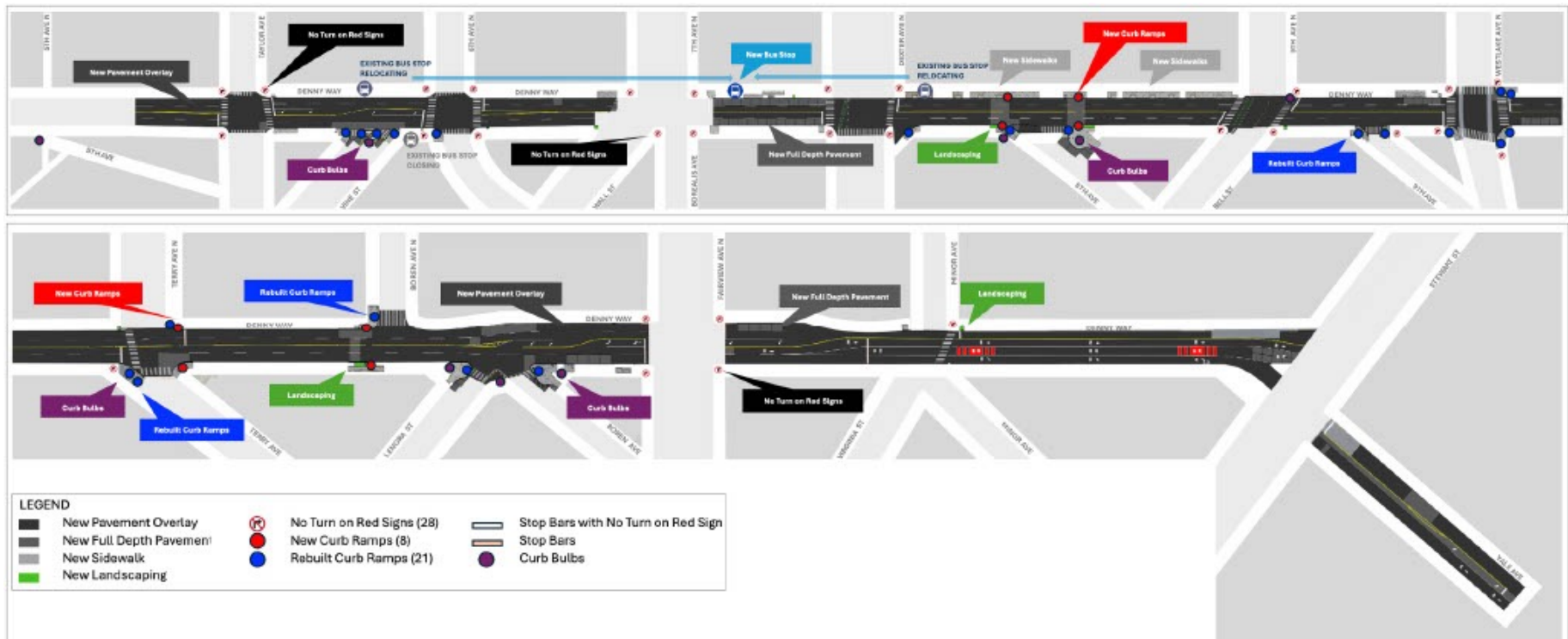

Why the Denny Way Paving Project?

- SDOT paves arterial streets in poor condition each year to make them **safer, smoother, and to extend their useful life.**
- Keeping our transportation system in a state of good repair helps **lower the cost of future maintenance.**
- Denny Way is a **critical piece of Downtown Seattle's arterial network**, and this project will restore the pavement condition on almost 12+ blocks.

Project Overview: Project Area



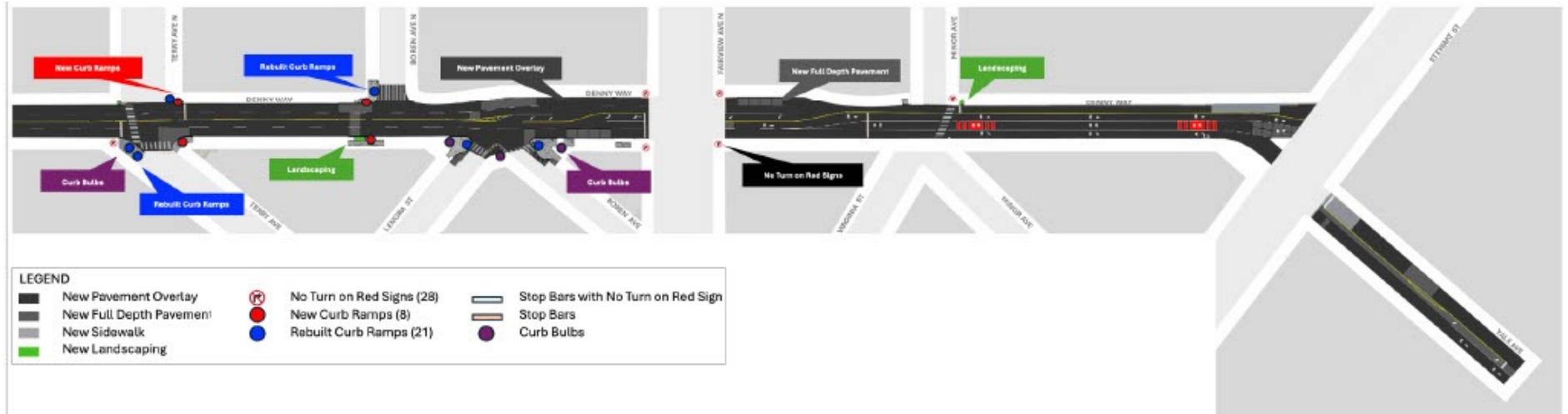

Denny Way

- Major Freight Route

Scope Summary

Pavement Preservation

- “Grind & Pave” construction includes new asphalt, repainted lane striping
- Drainage upgrades/modifications as required

Pedestrian Improvements

- Hardened centerlines reinforcing existing turn restrictions
- Sidewalk improvements, intermittent sidewalk repair and replacement work
- Bus stop consolidation to improve transit travel time and reliability
- Additional measures to reinforce existing turn restrictions
- No Turn on Red signs, stop bars, new and rebuilt curb ramps, curb bulbs

Project Overview: Schedule

Milestone	Date
Project Initiation	February 2023
Design	June 2023—January 2024
Construction Start	Early 2025
Substantial Completion	Fall 2025

Construction Mitigation

To minimize disruptions during construction, we have implemented several measures, including:

- Work will primarily **take place at night** to **reduce impacts on daily activities** and make it **easier to access businesses** during the daytime.
- Traffic **detours will be avoided** whenever possible.
- Paving will be done in sections, and we plan to **prioritize key segments**, such as consolidating Route 8 bus stops, **early in the process**.
- Work on the western half of the project to be **prioritized in the schedule** to ensure easier access to SR-99 for those seeking alternatives to I-5.
- Priority will be given to Route 8 buses when feasible.

Construction Considerations

- The Washington State Department of Transportation (WSDOT) Revive I-5 Project in 2025 includes pavement repair along I-5. Both SDOT and WSDOT will closely work together to **coordinate and manage impacts** to keep people moving while both projects are underway.
- We're communicating and coordinating closely with **major employers, including Amazon**, and will do our best to **reduce traffic during daytime commuting hours** by working mostly at night. While we do expect some delays, no major detours are currently planned.
- As return-to-work congestion, Revive I-5 and other major construction will complicate 2025 travel, we're working with partners at the **Transportation Options Program** to encourage commuters to create new travel habits, such as varying their work schedules, taking transit, biking, scooting, or walking.

Construction Impacts & Solutions

- Lane Reductions and Shifts
- Some Sidewalk Closures with Posted Pedestrian Detours
- Typical Construction Noise, Dust, Smell and Vibrations
- Temporary Intersection and Potential Short-Term Driveway Closures
- Some Parking and Loading Zone Restrictions Near Work Zones
- Off-Peak Work Hours Between 7PM-6AM Monday-Friday
- Possible Weekend Work When Needed
- Business Access Maintained
- Advance Notification to Businesses/Resident Surrounding Work
