
# **NOTICE OF DECISION ON RPZ 29 EXPANSION**

- All residents within the shaded area will be eligible for RPZ 29 permits and guest permits. Permits are currently \$65 per vehicle for a two-year cycle which begins November 1, 2017. There is a \$10 low income permit for qualifying residents.
- All employees within the shaded area will be eligible for RPZ 29 permits for their vehicles. Requests must be submitted by the business for eligible employees. All employee permits are currently \$65 for a two-year cycle.
- Zone 29 signs limit parking for vehicles without Zone 29 permits to 2 hours, Monday-Friday 7 AM – 6 PM.
- Zone 29 signs will not be installed adjacent to commercial properties or ground floor retail.

#### Background

SDOT has been active in Columbia City since early 2016 through the Community Access and Parking Program. This work began with a survey on parking and access in the neighborhood. In response to an open question on comments or ideas on area parking and access, RPZ expansion was the most frequent response. In spring 2016 SDOT conducted multiple area parking studies to determine which streets met RPZ expansion criteria and would likely benefit from RPZ expansion. In January 2017 we sent a proposal for parking changes in Columbia City, which included an expansion of RPZ 29, along with a survey. Over 75% of residents supported the proposed expansion of RPZ 29. The same expansion area was included in a June 2017 final plan we sent out. We have reviewed comments and feedback received on the final plan. The new RPZ blocks will match the blocks communicated in both our January 2017 proposal and our June 2017 final plan.

## NOTICE OF DECISION ON RESTRICTED PARKING ZONE (RPZ) 29 EXPANSION

The Seattle Department of Transportation (SDOT) has considered public input and is issuing a decision regarding the expansion of existing Restricted Parking Zone (RPZ) 29 in Columbia City. The map on the inside of this mailer highlights the areas where RPZ 29 is expanding.

We plan to install signs for the expanded RPZ area at the end of October 2017. We will mail applications for permits to addresses in the new expansion areas in late September. There are no changes to existing RPZ 29 blocks. Other elements of the Columbia City Parking Plan (paid parking, designated disabled parking, and unpaid time limits) are also planned for late October installation.
