RPZ 8 NOTICE OF DECISION Curbspace changes in Eastlake

SDOT Curbside Management staff held a public

hearing regarding proposed Restricted Parking Zone hearing regarding proposed Restricted Parking Zone (RPZ) 8 and other curbspace changes in the Eastlake neighborhood on August 15, 2023. Thanks to all those who attended, and those who provided feedback regarding these changes. Please see the reverse side of this mailer for details and a map describing the curbspace changes coming to the Eastlake area in spring/summer 2024.



The RapidRide J Line project is scheduled to start construction in Eastlake as soon as summer 2024. This project will upgrade the Route 70 bus line, install protected bicycle lanes, a new watermain and paving on Eastlake Ave E, plant more than 190 new trees, and bring many more upgrades. More information on this project is available at www.seattle.gov/transportation/RapidRideJLine.

The following curbspace changes are planned for spring/summer of 2024:

- SDOT will make the following modifications to existing RPZ 8 blocks:
 - Convert all Zone 8 4-hour maximum parking to 2-hour maximum, except by permit
 - Remove all "No Parking 6PM Midnight, Except by Zone 8 Permit" restrictions
- SDOT will add new RPZ 8 areas, allowing 2-hour maximum parking, 7AM – 6PM, Mon – Sat, except by permit
 - New RPZ blocks are scheduled to be installed to coincide with the zone renewal cycle July 1, 2024, so new permit holders do not have to pay twice for permits
 - Residents on new RPZ 8 blocks will receive a mailer with instructions on how to purchase RPZ 8 permits, including information on the \$10 income-eligible permit, prior to sign installation
- SDOT will convert general 1-hour time-limited blocks to 2 hours (7AM – 6PM, Mon – Sat)
- SDOT will add general 2-hour time-limited blocks (7AM – 6PM, Mon – Sat)
- SDOT will add 4-hour paid parking adjacent to commercial parcels in the southern area of the neighborhood. Rates and hours will match the existing paid parking area to the south and are currently enforced 8AM – 6PM Mon – Sat
- SDOT will relocate load zones from Eastlake Ave E to side streets. For Eastlake loading questions, please contact us at RapidRide@seattle.gov
