Aurora Ave Project

Project Description

SDOT, in partnership with King County Metro, has begun working on a new design vision for Aurora Ave. This is a joint long-range planning study that will, with input from impacted stakeholders and members of the community, inform the scope and vision of the project. The project seeks to:

- Improve safety for all travelers and connections to transit along Aurora Ave N
- Improve accessibility and safety
- Reduce collisions for all users

- Develop a design vision that enhances safety, mobility, and accessibility for all travelers
- Identifies transit service improvement and connection needs
- Addresses the needs of residents, businesses, and corridor stakeholders

Key Findings After Survey #1

Through both in-person and online outreach, more than 59,000 community members were able to offer their feedback on their priorities for the corridor. Some of the key findings included:

- Safety improvements for walkers like signaled crosswalks and barriers between them and the street.
- A need for additional bike lanes separate from the road.
- Better bus maintenance and frequency in some directions.
- Traffic control measures to reduce collisions.
- Increase in street lighting.
- A variety of social concerns such as personal safety, crime, sex work, and homelessness.

All social concerns were shared with the Seattle Police Department and the Human Services Department to help inform their ongoing efforts to address these social issues. We will also continue to take these concerns into account as we explore design options for the corridor and its transit services.


- Between April and June we will be conducting Community Design Workshops to learn how community members along the project area would address the priority issues identified in survey 1.
