

# \*\*\*IMPORTANT NOTICE \*\*\*

## PLEASE READ CAREFULLY

Your street will be closed to traffic, including bicycles, between the hours of 7:00 a.m. and 5:00 p.m. on the following date: \*\*See Back Side of Notice\*\*

Your street has been selected to receive a Slurry Seal application to extend the life of the pavement. Slurry Seal consists of asphalt emulsion and aggregate that will require three to four hours to dry before it is ready for traffic. If you wish to use your car on the date of treatment, we recommend that it be parked on a different street that is not scheduled to be sealed prior to 8:00 a.m.

### **\*\*Cars parked within the posted work area will be towed away at the owner's expense.\*\***

Once applied, Slurry Seal materials can stain your car, carpets and floors if driven on or walked upon before the treatment has fully dried. Please do not wash cars or water lawns on the day that work is scheduled. Emergency vehicles will always have access.

This street closure is designed to only inconvenience residents once. Our intention is to protect the roadway and personal property during our work. Please keep in mind that once we have placed this product on your street you will not be able to leave your driveway until the street has been opened back up to traffic. You may walk on pathways or sidewalks parallel to the street.

For their safety, please keep children and animals away from the area while construction is in progress. If the date of work scheduled is your normal trash/sanitation day, please set out your garbage the night before or no later than 6:30 a.m. the morning of to allow cans to be picked-up prior to the application of the slurry seal. There will be no other impacts to trash pick-up.


We realize the inconvenience that this creates and thank you for your patience as we do our best to minimize disruption.
