### 1. Welcome & Introductions

- SWAC Chair, Joel Dashnaw, called the meeting to order at 5:35 PM
- Members and guests introduced themselves. Prompted by the SWAC chair, they each shared their name, affiliation, and their favorite spring activity in Seattle.
- Quinn Apuzzo was introduced as the new SWAC coordinator for SPU. Her start date is scheduled for May 11. Katie Lynd will still provide SWAC support as needed, through her Solid Waste liaison role in Community Affairs.
- April meeting minutes were approved by SWAC members in attendance

# 2. Comments on SWLOB Updates for SWAC

SWAC members were asked to review the updates in advance of the meeting. The Solid Waste Deputy Director was available to answer questions

- A SWAC member asked, "How has waste transportation changed with more staff being hired by SPU?"
- A SPU member responded, Our transfer stations recently had a shortage of truck drivers available, so we were unable to move as much waste as we have in the past. Those numbers have increased as we have been able to fill vacancies.

## 3. Food Rescue Program Update & Pilots

Liz Fikejs gave an overview on the Food Rescue Innovation Program.

- A SWAC member asked, "What are the strategies to ensure the QR code on reusable donation bins does not fade or become inaccessible after being washed repeatedly over time?"
- A SPU member responded, The bins don't currently have QR codes, but If we were to
  expand beyond this pilot and include QR codes in the future, they could be heat stamped
  onto the bins.
- A SWAC member asked, "Is there a long-term plan to finance this program?"
- A SPU member responded, SPU is performing a cost-benefit analysis to assess potential savings for grocers to use these bins. The analysis might show that paying for bins and bin servicing could be less expensive and more effective than retailers' current systems for managing food waste and food donation.
- **A SWAC member asked,** "What is the advantage of using this program instead of going through a resource recovery company such as Divert?
- A SPU member responded, Divert bins are intended to collect food scraps not donatable food. Right now, we're seeing that almost all food donatable food or food scraps are going to Divert. Grocers using services like Divert pay to receive a certain number of Divert bins. But if their food waste exceeds the capacity of the bins, the food goes into the garbage. By using the donation bins, we hope grocery staff will stop putting donatable food into Divert's food scrap bins. And if they do this, hopefully less food will go to garbage.

### 4. Recruitment Update & Survey

SWAC members were asked to participate in upcoming recruitment for members.

#### 5. Commercial Recycling/Outreach & Reuse

Pat Kaufman provided an overview on SPU's Commercial, Recycle, Compost and Reuse efforts.

- **A SWAC member asked,** "Is there a model similar to what Ridwell uses that SPU can benefit from for creating a washing station for the reusable boxes?"
- A SPU member responded, SPU may not have the resources to take this on ourselves. Ideally, we would want to find an organization to partner with that can assist with these efforts.

### 6. Letter of SWAC Involvement on 2022 Plan Update

SWAC members are required to show how they have been involved in the development of the 2022 Plan Update by July 1.

• SWAC participation was detailed in a letter in 2011. This can be an option for this year, but a letter is not required.

- SWAC can also utilize the SWAC Involvement Log which is a document that has been maintained by SPU
- SWAC Officers will find specific SWAC members to assist with presenting SWAC involvement in the Plan Update
