The Saving Water Partnership recommends that you choose a landscape contractor who is certified as an irrigation specialist by a professional organization. A certified specialist is your best resource for quality system maintenance, repair and backflow services.

Below is a brief description of each certification:

#### Irrigation Association (IA) www.irrigation.org

## Certified Irrigation Contractor (CIC) <a href="http://www.irrigation.org/cic/">http://www.irrigation.org/cic/</a>

Manages contracts and subcontracts to install, repair, and maintain irrigation systems in such a manner that projects can be executed in an acceptable way, meeting all specifications and requirements, including irrigation layout, installation, maintenance and repair of systems.

#### Certified Irrigation Designer (CID) <a href="http://www.irrigation.org/certification/CID/CID.aspx">http://www.irrigation.org/certification/CID/CID.aspx</a>

Evaluates site conditions and determines net irrigation requirements based on the needs of the project, including selection of the most effective irrigation equipment and design methods. The objective of a CID is to establish specifications and design drawings for the construction of an irrigation project.

#### Certified Landscape Irrigation Auditor (CLIA) <a href="http://www.irrigation.org/certification/CLIA/CLIA.aspx">http://www.irrigation.org/certification/CLIA/CLIA.aspx</a>

Collects landscape data, makes irrigation maintenance recommendations, performs irrigation system audits, and develops base irrigation schedules.

#### Certified Landscape Technician (CLT-Ir) http://www.walp.org/landscape-industry-certified

Understands basic landscape maintenance practices, and demonstrates irrigation system and water management skills.
