1. Welcome & Introductions

2. Solid Waste Metrics for Annual Reporting Draft Presentation

• Stephanie and McKenna presented the new solid waste data metrics for the waste generated by residents and businesses in Seattle. They discussed how success will be measured in the future using five priorities and emphasized the utilization of waste prevention planning and implementation of policies and programs to reduce waste.

3. Waste Prevention Strategic Planning Initiative Presentation

• Veronica presented the Solid Waste Plan Update to define metrics and targets related to waste prevention. The presentation measures triple bottom-line environmental, economic, and societal improvements.

• SWAC members were prompted with a question about what our daily lives might look like in the future, where waste prevention is a way of life. The members provided ideas on the future success of their initiatives and the conditions necessary for their success.

4. Ecology Updates (Presented by Katie Jerauld)

- Ecology will be launching a \$10 million grant program for organizations working to improve air quality in overburdened communities. The application period is from August 29th- October 24th.
- There have been a few changes to the 2024 Organic Management Law.
- Ecology is working on a compost document ordinance reporting form.
