- 4K per house 6k per commercial building for deconstruction offered
- Deconstruction is more labor involved and takes longer than demolition
- SCDI priority green incentive program, sent to SCL for quicker disconnect to help save money as time=money in demo and deconstruction. Sometimes the 4k-6k covers the cost difference.

- Creating circular economy for solid waste infrastructure for re-use. Awarded 4 million for pilot. Bidding is out and we will use the 4mill to help get it up and going.
