2. Agenda/Minutes

- a. December 5, 2024 minutes were approved 6-0.

4. New Business

- a. **Future Water Supply Alternatives Project:** Elizabeth Garcia shared an early look at this project evaluating a broad range of options for how SPU might expand our water supply, in preparation for if/when additional water is needed. The project includes six primary supply options, with seven secondary options. The approach is a multi-objective decision analysis and will include scenario planning. The project is scheduled for completion in mid-2026.
- b. Lake Youngs Sinkholes: Paige Igoe and Ulysses Hillard provided updates on two large sinkholes at Lake Youngs. Sinkhole #1 is located on the perimeter dike road and exposed a duct bank including the lines that provide chlorine to the treatment plant. It was initially observed on Nov 6, 2024 and is being addressed in several phases including stabilizing the pipes/conduit, grout injections, re-bedding the utilities, and rebuilding the road surface. Sinkhole #2 is located near the old Lake Youngs pump station and the void extends to under the building foundation. It was initially observed on Nov 22, 2024 and is being addressed by grout injections and monitoring via piezometers and survey points.
- c. **SPU's Hazard Identification & Vulnerability Analysis:** Chad Buechler and Michael Godfried gave an overview of SPU's Hazard Identification and Vulnerability Analysis (HIVA), which is the foundation of SPU's emergency management work, including SPU's AWIA's Emergency Response Plan which is currently being updated. The HIVA addresses all three of SPU's Lines of Business (Water, Drainage/Wastewater, Solid Waste) and includes 21 potential hazards.

5. Executive Summaries & Other Business

a. **Water Consumption – Actual Compared to Rate Study:** Julie Crittenden shared that actual annual consumption to date is the same as the 2020 Rate Study projection and 4% lower than this time last year.

- b. **Water Supply Update:** Julie Crittenden reported that cumulative precipitation, storage, and consumption are close to long-term averages. Snowpack is less than the long-term average, but similar to last year. Due to the lower snowpack, SPU is keeping an eye on supply management tools to maximize supply through the year.
- c. **Next Meeting:** March 6, 2025. In person only at Mercer Island.

6. Good of the Order

- a. **Hobo Creek:** Jorgan Peadon shared his experience attending SPU's internal Stage Gate process meeting for the Hobo Creek Cedar Falls Road project.
- b. **Flouride:** Alex Chen reminded the group that there continues to be movement and news stories related to opposition to water utilities adding fluoride to drinking water.
- c. **Cascade Blending Study:** Alex Chen shared that Cascade is conducting a water blending study (Seattle and Tacoma water). They have asked SPU for data and we are providing it. The study is independent of the issue of wheeling Tacoma water thru SPU infrastructure.

Board meeting was adjourned at 2:55pm and the group was encouraged to enjoy the provided holiday snacks.
