### 2. Agenda/Minutes

- a. April 3, 2025 minutes were approved 5-0 (1 Operating Board member was absent).
- b. June 5, 2025 agenda was approved 5-0 (1 Operating Board member was absent).

#### 3. Old Business

6-Yr Capital Improvement Plan (CIP) - Part 3 Final Table & Vote: Julie Crittenden gave a short presentation to wrap up the Operating Board's annual review of the regional CIP. She reminded the group of the process this year including the new CIP Book and the optional CIP workshop held on April 24. There were no additional questions on the CIP. The Operating Board chair called for a vote to acknowledge that the 2025 CIP review process was completed. The vote was approved 4-0 (1 Operating Board member from SPU was absent and the wholesale Medium Category representative abstained from voting because the Medium Category did not caucus.)

#### 4. New Business

- a. Climate Change Hydrology Analysis: Julie Padilla provided a detailed briefing about this project which examines climate change impacts to hydrology. The major takeaway are: 1) the shape of the hydrograph is changing from "rain-snow transition zone" dominated watersheds to "rain" dominated watersheds, 2) warming summer temperatures may increase the rate of drawdown, 3) the climate change hydrology update can help us answer climate-related questions across a variety of other planning projects.
- b. **Spring Water Supply Update:** Elizabeth Garcia provided the annual spring water supply briefing to share what our water supply looks like heading into the spring and summer months. We have had a drier than average winter and spring. We have also had a lower than average snowpack and thus SPU made several operational adjustments (e.g., refilling earlier and higher). Based on current conditions and forecasts, Seattle anticipates the regional water system will have sufficient water supply for people and fish for this summer. Elizabeth shared that Ecology will be announcing an expansion of their drought emergency declaration to include additional areas including King County, however it will specifically exempt the Seattle (and Everett and Tacoma) regional system.
- c. Trenton Facilities Improvement Project (CIP# C600594; CIP Table Row 12a): Cedric Joaquin provided a "Pre-Stage Gate 2" presentation of this project which addresses deficiencies at the Trenton standpipes and turbines/pumps. The cost of this project is in the SW Subregional Cost Pool. The presentation covered the need for the project, the options analysis that was conducted, and the

preferred option of demolishing both standpipes and building a new pump station. The preferred option will be presented to SPU's governance group for approval in the near future.

#### 5. Executive Summaries & Other Business

a. **Water Consumption – Actual Compared to Rate Study:** Julie Crittenden shared that actual annual consumption to date is 2% higher than the 2020 Rate Study projection and 2% lower than this time last year.

b. **Water Supply Update:** This item did not warrant discussion due to the detailed Spring Water Supply Update given by Elizabeth Garcia in Agenda Item #3b.

## 6. Good of the Order

- a. Lake Youngs Sinkholes: Alex Chen gave updates on the two sinkholes at Lake Youngs (more details have been provided at previous Operating Board meetings). The work on Sinkhole #1 (on the perimeter dike) is essentially complete. The work on Sinkhole #2 (near the old Lake Youngs Pump Station) is still underway.
- b. **Fluoride:** At the request of a wholesale customer, Alex Chen gave a brief update related to the national developments regarding fluoride. He said SPU is following those developments closely and if the federal (or WA state) government at some point says we could no longer fluoridate our water, that of course we would comply. However, currently fluoridation is allowed in Washington and we continue to follow long-standing guidance on the benefits of fluoridation.
- c. **Facility Tour Spots:** Kelly O'Rourke mentioned there are 13 spots on the June 24<sup>th</sup> wholesale customer tour of the Cedar River Watershed and people should contact her if interested in attending. The other four tours are essentially.
