## **Land Acknowledgement**

Commissioner Lewis - This letter is regarding the Federal Fair Housing Act, which currently doesn't include marital or partner status. The want is to close this loophole in the Act.

- Mercy Housing is the largest builder of public affordable housing in the Nation. Secular roots.
- National Presence, regionally in WA, ID & OR with >50 communities.
- Rehab and lending along with resident services. Demographics: avg household income is <\$25709/yr with living for ~7yrs</li>
- 19 projects in active pipeline in WA & OR
- 1400 units opened between 2022-25
- Key Partners: City of Seattle, KC, Pierce County, WA St HTF,
- Transit Oriented Development, Early Learning Centers, Facilities with Healthcare Hubs.
- Resident Services provided on site, food pantries, health care clinics and mobile clinics, financial and housing stability services, banking partners, engagement voter registration
- Housing Development Consortium works on policy reform and advocacy to clear the path for developers to build the properties.
- Policy Needs: zoning & land use reform, counter NIMBY opposition
- Funding; protect & grow housing trust funds, support services & operating subsidies
- Community Voices; mobilize letters & testimonies, partner w/faith schools and orgs
- There is a Lobbyist working with Mercy Housing.
- Always looking for volunteers and donations for drives.
- Education program Mercy Scholars, engage parents especially those who are ESL along with students to support kids in schools.
