**Term Length, Board Category Re-Evaluations & Seattle Rotation**

- Customer categories are to be recomposed January 1, 2012 \*\*
- Determination of Categories will be based on ERU's. *The formula used: Annual purchases from SPU in 2010 (in ccf) divided by the average annual ERU for the Seattle regional system (6.8 ccf per month x 12 = 81.6, rounded to 82) \*\**
- Utility Representative – Official representative to Operating Board, primary point of contact, eligible for nomination to OB and participates in caucuses\*\*\*
- Seattle and the 7<sup>th</sup> independent member are considered separate categories\*\*\*
- Operating Board Member Terms = 4 years\*
- One Seattle member term expires at the same time as each of the Category member term expires\*
- Categories are to be re-evaluated every 5 years beginning January 1, 2012\*\*\*

- \* Full/Partial/Block Wholesale contracts Exhibit IV and OB By-Laws Section 5 – Terms of each Board position shall commence on January 1 and shall be for four (4) years and each Board position shall be staggered such that no more than two positions are renewed in any single year. Board members may serve not more than three successive terms.
