1. Welcome, Introductions & Announcements:

Diane Pottinger, Operating Board (OB) Chair, welcomed everyone to the meeting.

Kathy Curry, Wholesale Water Contracts Manager, confirmed Board Member attendance, noting that Ron Speer, Large Utility Category Board Alternate, would be acting as Board Member in Matt Everett's absence.

Alex Chen, Seattle Public Utilities (SPU) Deputy Director Water Line of Business and Shared Services, shared some announcements.

2. Agenda/Minutes

- a) The July 1, 2021 minutes were approved 6-0.
- b) The August 5, 2021 agenda was approved 6-0.

3. New Business

a) Reclaimed Water

Alex Chen provided a presentation on Reclaimed Water, reminding the group of the background and potential County projects. Alex also shared an update on discussions with King County, County-provided water quality data, and capital cost considerations. Following Alex's presentation, the group discussed reclaimed water and next steps.

b) Earthquake Resistant Pipe Materials

Bill Heubach, SPU PE, provided information on earthquake resistant pipe materials. As part of his presentation, Bill shared information on earthquake hazards and water main failures associated with significant earthquakes over the last three decades. Bill gave an overview of SPU's standards for water main design, construction and performance, and described the circumstances where earthquake resistant pipe is required and the different earthquake resistant pipe types. Bill also went over seismic hazard resources and design and construction considerations.

c) Incident Command System Training

Chad Buechler, Emergency Management Manager with SPU Risk and Quality Assurance, shared information about two Incident Command System (ICS) combination courses that SPU will be hosting in September and encouraged participation.

5. Executive Summaries & Other Business

- Contract Review Updates Alex Chen shared some information on behalf of Mami Hara and reminded the group of the financial mechanics contract workshop scheduled for August 10 and the workshop scheduled for August 25 that would be focused on Shared Long-Term Water Supply Planning for the region. Alex also relayed that a contract process extension letter would be going out to each utility and thanked everyone for their participation and feedback on the process.
- Water Consumption from Watersheds vs. Rate Studies Alex Chen went over Att. 4a.
- Water Supply Update Paul Faulds presented information shown on Att. 4b.
- Other Updates:
 - Alex Chen shared that the City of North Bend has signed an agreement that allows them to be part of the regional Saving Water Partnership water conservation program, effective September 1, 2021.
