

Night Owl Investments

- Create a late-night network that operates on all-day services
- Replace 82, 83, 84 with service on Routes 3, 5, 11, 70
- Add Routes 44, 48, 65, and 67
 - Provides connectivity between routes with night service
 - Provides missing coverage for Northeast Seattle



RSJ Analysis

- Assessment is underway
 - Review by SDOT Change Team
 - Includes mapping of Metro & STBD service investments
 - Evaluation of various demographics
 - People of color, low-income households, people with disabilities, zero-vehicle households
- Outcomes
 - Review past STBD investments in association with RSJI principles
 - Inform future work

RSJ Analysis – Potential Investments

- Areas of focus:
 - Neighborhoods near city limits
 - South and North Seattle
 - Southeast Seattle
- Considerations:
 - Improve Frequent Transit Network routes
 - Regional partnership routes

Frequent Transit Network

- Differing definitions of "Frequent Transit"
 - Transit Master Plan
 - Move Seattle
 - RapidRide policy
 - Land use/ Parking code
- Proceeding with unified definition consistent with internal and external policies



- Move Seattle 2025 Goal: 72% of Households within a 10-minute walk to 10minute or better transit service
- 2017 Seek to increase this coverage
