Call to order:

Drue Epping, UFC Chair, called the meeting to order, conducted a roll call of the commissioners and reviewed the agenda.

Public Comment:

David M: Noted May 30, 2025, the Tree Planning Study via the SDOT website (linked in Chat). Noted that this planning was funded by a grant from the DNR to study underserved communities (provided examples: Capitol Hill, page 3; Roxhill, SODO, South Park). Noted that reports show the City's efforts toward equity. Tree canopy cover and the impact from planting trees was discussed. Concern/Contention raised: Tree planting could benefit tree canopy impact from being planted on private land.

Steve Z: Noted concerns over vacancies regarding Position 4 – Hydrologist; Position 6 – NGO; and Economist and urged the UFC to post notices to fill these positions.

Concern: Comprehensive plan; Ordinance 120993. Followed up in Chat with:

Sandy S: Noted current City of Seattle talks with Planet Geo. Noted that previous a tree canopy study did not include plantable areas, volume of canopy present/lost; and it didn't include influence of stormwater. Noted concerns about the study in these regards.



Adoption of Meeting Notes from July 9, 2025:

Meeting notes were reviewed and unanimously adopted with minor revisions to correct the spellings of two commissioners first names.

UFC Commissioner and Liaison updates

Timeline: Public Hearing to discuss the DRAFT One Seattle Comprehensive Plan Amendments on September 12, 2025, and Council will hear on these changes September 17, 2025.

UFC Decision: One Seattle Comprehensive Plan recommendation

Summary: The UFC recommendation letter intends to create highest impact and preserve ecological value, and therefore suggested some revisions and affirmed some statements:

- R1 and R2: Commissioners are in favor of these recommendations and thanked the subgroup. There will be no changes in these sections.

Revision: A discussion was made regarding R3. Suggestion: There should be a notable incentive between retaining large trees versus planting new ones.

Suggestion: Tristan offered to work on diagrams. NR Tree Analysis was referenced. A future diagram could use reference specific codes, e.g., the profile of the house and any setbacks. Drue noted elevating soil volume minimums.

Vote: The UFC held the vote to approve the Comprehensive Plan letter of recommendation with changes: Tristan moved, Alicia seconded, and the UFC unanimously approved the changes on the document.

Steve Z: Provided comments that this is an opportunity for the UFC to give feedback to the City Council and it will have significant impact and take a position on 15 amendments. Point 102.

David M: 2021 Tree Canopy Assessment – 7000 acres. As the UFC thinks about Seattle for future generations, what is the long-term impact of this legislation. Referenced Portland mandated 20% of the canopy.

Thank you, UFC, for your time. Summary of an ask to the UFC is to (a) invite SDOT's Katey Bean, Senior Landscape Architect of SDOT Urban Forestry, to go through the 7 page reports and their recommendations, (b) UFC discussion to your recommendations to the Mayor and City Council for just these 4 communities, (c) suggest funding for similar additional studies for low-canopy census tracts (i.e. Northgate, Georgetown) and (d) submit your UFC letter to Mayor and City Council with a follow-up timeline (which could be 12 to 18 months). It appears (page 3 in each report) that these four communities will mathematically not be able to match other Seattle communities without incentives provided for Seattle's historically disadvantaged communities. One strategy is Portland Oregon's minimum 40% for less than 6 dwellings and 20% land area for 6 or more dwellings. A second strategy in these neighborhoods is to require adding trees in property sales and renovations (city-funded based on homeowner income) as often real estate transactions are preceded by vegetation reduction or the property had no or maybe one tree. However, this exterior amenity area at LR1 townhouses is often part of a 5-foot wide setback distance that includes underground sanitary sewer, domestic water, and power line trenches.
