Guest: Washington Talking Book & Braille Library by JJ

- News at state and federal level cuts in funding. Federal funds cut and legal action require re-enact existing grants.
- Bill on Governor's desk, use court recording fees to fund library among other.
- Notice of last day for employees, June 30th
- Stark reduction of services with up to 50% layoffs. The Seattle Disabilities
- The Commission advocates all federal, state and local elected officials to sustain funding for the Washington Library. The loss of access to services will impact over 9000 people across the state of Washington, the loss of employment and the families impacted. We think of those Washingtonians who depend on access to materials such as brail, audio, or lack of mobility. Library, 19 employees cover whole state (nearly 9,000), run through Postal Office (service prison, elderly, disabled lack of mobility, create braille materials (ballots, books, etc.)

- What kind of advocacy to state or federal level? These commissions advise the mayor and city council can reach out to advocate.
- Scott has a list of all the elected officials at all levels of government with contact information.
- Impact of this service, 9,000 people, families of all employees, prisons
- Does a letter, social media must be voted on webpage, blog page? Should we contact Sebastian or Sage? Can highlight some of these points.
- Bianca made the motion, JJ seconded this message allowing the co-chairs to share this message: The Seattle Disabilities Commission advocates to all federal, state and local elected officials to sustain funding for the Washington Talking Book & Braille Library. The loss of access to services will impact over 9000 people across the state of Washington, the loss of employment and the families impacted. We think of those Washingtonians who depend on access to materials such as braille, audio, or access in their homes to these services (through postal system). This will limit production of materials audio, braille with a specific Northwest focus, and access to information about elections.
