**I. INTRODUCTION**

The Community Police Commission (CPC) supports the City of Seattle's Accountability Ordinance,<sup>1</sup> passed by the Seattle City Council on May 22, 2017 and signed by the Mayor on June 1, 2017.

The CPC respectfully requests that the Court issue an order holding that nothing in the ordinance is inconsistent with the consent decree. The ordinance is a major improvement in

1 Seattle's accountability system and passes the "three levels of scrutiny" identified by the Court<sup>2</sup> in  
 2 that it moves the City toward policing (1) that complies with the Constitution; (2) that allows police  
 3 to be effective; and (3) that the people of the community can have confidence in.

4 The CPC asks that the Court enter an order opening the door to full implementation as soon  
 5 as possible.<sup>3</sup> The current accountability system—preordinance—is under significant stress. The  
 6 OPA auditor position has been filled by an interim officeholder with a limited mandate since last  
 7 October. The OPA director has recently announced his resignation. And the OPA Review Board  
 8 has all but ceased to exist. The City is taking preparatory steps to fill the OPA Director, Inspector  
 9 General, and new CPC positions. For these reasons, there is an urgency associated with  
 10 implementation of the ordinance.

## 11 II. CONCLUSION

12 The success of reform is never guaranteed, but this ordinance is an opportunity to create  
 13 lasting, positive change. The Community Police Commission, therefore, respectfully asks the  
 14 Court to adopt the recommendations of the Commission as stated herein.
