### REVIEW AGENDA AND APPROVE MINUTES / ANNOUNCEMENTS

**Moved, seconded, and passed (8-0-0):** "To approve with no changes both drafts 12/11/13 and 1/8/14 CPC meeting minutes."

This was the last official CPC meeting for Joe Kessler. He has been promoted to Assistant Chief in the Seattle Police Department. He said he appreciated serving with the group and was proud to be associated with the exemplary work of the CPC. Joe introduced Lt. Ron Rasmussen as his likely replacement—he has been recommended to the Mayor for the SPMA position on the CPC. Ron shared with the group that he is passionate about police work and doing it right. Lisa Daugaard added that the CPC is unique from any other police accountability group in the country, because of its involvement of the SPOG and SPMA.
